NOTICE OF INTENT TO CONSTRUCT AN ANIMAL FEEDING OPERATION

Notice is hereby given that the South Dakota Department of Agriculture and Natural Resources (DANR) has received a revised application for state permit coverage under the 2017 *General Water Pollution Control Permit for Concentrated Animal Feeding Operations* (general permit) for a new animal feeding operation from:

Plainview Dairy, LLC Mike Vander Dussen 729 East Jefferson Road El Nido, CA 95317

A public notice for Plainview Dairy, LLC was originally published in the *Clear Lake Courier* on February 14, 2024. The revised application includes a solid manure stacking pad which is a different type of manure or process wastewater containment structure requiring a new public notice. The revised application also includes other changes to the approved manure management system.

The proposed dairy operation will be located in the North ½ of Section 17, Township 113 North, Range 49 West in Deuel County, approximately ten miles south and two miles west of Clear Lake. The proposed operation will consist of housed lots for a maximum of 9,500 mature dairy cattle. The manure management system will now consist of two existing manure pack barns, a freestall barn, a milk parlor, a separator building, a solid manure stacking pad, a feed storage pad, a runoff holding pond for the feed and solid manure stacking pads, two covered holding ponds, and 24.0 acres of drainage area. The designed capacity of the manure pack barns and solid manure stacking pad is for at least 270 days of solids storage capacity and the designed capacity of the holding pond system is for at least 365 days of liquid storage capacity. The manure will be land applied to fields located in portions of the following sections in Deuel, Hamlin, and Brookings Counties.

Deuel County:

Section 18 in Township 113 North, Range 47 West; Sections 3, 18, 23, 32, and 33 in Township 113 North, Range 48 West; Sections 4, 8, 10, 13, 14, 16, 18, 20, 21, 23, and 24 in Township 113 North, Range 49 West; Sections 18 and 31 in Township 114 North, Range 47 West; and Sections 5, 12, 13, 14, 15, 16, 21, 27, 34, 35, and 36 in Township 114 North, Range 48 West.

Hamlin County:

Sections 18, 20, and 30 in Township 113 North, Range 51 West.

Brookings County:

Sections 5, 7, 10, 15, and 27 in Township 112 North, Range 47 West; Sections 1 and 2 in Township 112 North, Range 48 West; and Sections 2, 3, 4, 5, 10, and 16 in Township 112 North, Range 49 West.

general permit requirements must submit written comments within thirty (30) days of the publication of this notice. Commenters shall provide their name and address, a statement of the action they wish the department to take, and the facts supporting their position.
