



### RFP's

#### 22. Mop Sink Closet - Intermediate Level

- a. Per Owner discussion, it was decided to add a mop sink to the intermediate level floor plan at the South Building. A door was added and a closet was created in a portion of a mechanical chase.
  - i. \$7,566

## 23. Miscellaneous Scope Revisions

- a. This RFP covers several changes outlined below.
  - i. Revised flooring and added blocking for wood slat wall in President's Office 126.
  - ii. Relocated and added casework in Classroom 223, including added plumbing for sink.
  - iii. Addition of 2 door frames in lieu of re-used frames.
  - iv. Revision of flooring to carpet in Circulation 401.
    - 1. \$26,061

#### 24. Added Site at Handicap Stalls

- a. The existing grading along 11<sup>th</sup> St. does not meet grade requirements for accessibility. To provide handicap stalls near the west entry, it was discussed to revise the slope to be accessible and extend the work area to provide new asphalt in lieu of spot patching and leaving as-is.
  - i. \$35,390





# LAKE AREA TECHNICAL COLLEGE – DENTAL ASSISTING REMODEL CHANGE ORDER #01 – EXECUTIVE SUMMARY

### RFP's

#### 1. Added Doors and Finishes

- a. Per Owner direction, it was decided to replace 6 existing doors with new doors. New flooring and paint for Dental Office 136 was added as well.
  - i. \$15,622

### 2. Lounge 125, Ceilings, Casework and Furring

- a. During on-site conditions and tie-in with existing materials, it was decided to revise the layout of Lounge 135 to delete the tile wall on the S side and add a casework bench.
- b. Added furring to slightly increase wall thickness was required in 3 locations to accommodate MEP/Dental Equipment rough-in within the wall.
- c. Per on site coordination, the ceiling heights and edge condition around the wood ceiling at the reception desk was revised to reflect a similar condition to the soffits in Archway.
