BACKGROUND INFORMATION:

Background:

Owner, Williston, Inc, has submitted a petition for annexation and zoning for a portion of their property to be known as Williston Annexation First Addition. The property includes approximately 33 acres and generally located west of 78th Street West (Old Hwy 139) and north of US Hwy 212. The property is contiguous to city limits from the east and is proposing to be temporarily zoned R-1 Single Family Residential District. The property petitioned to be annexed and zoned conforms to the minimum district requirements of the R-1 District. The property is within the Sioux Rural Water Territory and the applicant will work with Watertown Municipal Utilities to meet the requirements the consent decree. Subsequent rezone requests will conform to the approved Concept Plan for the Williston Development.

The Plan Commission recommended approval to City Council at the September 8th, 2022 meeting (7-0).

Petitioners further request the zoning ordinance of the City of Watertown be amended to provide said property with the zoning designation of R-1, Single Family Residential District.


