BACKGROUND INFORMATION:

Fees have been paid and a Notice of Hearing has been published on December 28th, 2024.

The property received Conditional Use approval from the Board of Adjustment for a Bar or Tavern in the C-3 Highway Commercial District on May 6th, 2021 to allow for on-premise / on-sale alcohol licensing, sale and consumption. See attached Zoning Verification Letter for more details.

To Whom It May Concern:

The property described above received a Conditional Use approval from the Board of Adjustment for a Bar or Tavern in the C-3 Highway Commercial District, pursuant to Chapter §21.2803 3. on May 6, 2021 (5-0) which allows for on-premises/on-sale alcohol licensing, sale, and consumption. On June 7, 2021, a retail (on-sale) liquor and video lottery license was approved by City Council.

The previous business vacated the location at 714 9th Avenue SE in April 2024 which utilized the bar or tavern conditional use. The license was transferred on April 15, 2024 retail (on-sale) liquor and video lottery license from the location. §21.0202 2. (8) states: "In any case where the holder of a conditional use permit issued under City zoning ordinance has not instituted the use or begun construction, as applicable, within one year of the date of approval, the permit shall be null and void. Similarly, any such conditional use, upon its cessation or abandonment for a period of one year, will be deemed to have been terminated." One year has not been exceeded since the bar or tavern use has been in place at the location of 714 9th Avenue SE which allows for the use to continue and a new alcoholic beverage license be issues at the location.
