#### **BACKGROUND INFORMATION:**

The scope of this project is to install a new fitness course system at River Ridge Park. This playground will be part of the River Ridge Park Development. The footprint of this project will be approximately 93' x 55'. Surfacing for this equipment will be purchased out of the 2025 CIP Budget.

#### FINANCIAL CONSIDERATIONS:

The funding for this project was budgeted in the 2024 Park & Recreation Capital Improvement Fund, account 212.45182.43948 in the amount of \$144,350.15.
