NARRATIVE:

On 6/2/21 I was assigned this investigation. I contacted KCSO Deputy Ross and took possession of several documents to include a CPS referral, a report from Sunrise SCF (Second Chance Foundation), as well as two photographs. All the documents have been added to the case file. On 6/1 Chris McLaughlin contacted Child Protective Services and reported his soon to be ex-wife, Dawn McLaughlin, called him crying that morning at 1034 hours and told him she had a sexual relationship, with a minor, 2.5 years ago while the juvenile was housed at the Parke Creek Group Home. Dawn is employed as a cook at the facility, which lies within Kittitas County.

I then reviewed the report from Sunrise SCF, authored by Mathieu Guettinger. It is believed the victim in the sexual assault from 2.5 years ago is CHILD (DD). The report stated that Wendell Downs, CHILD had contacted Sunrise and spoke with staff member James Webb, who reported the incident to Guettinger. Through investigation, it was determined that CHILD Jermaine Smith, was the person responsible for contacting Sunrise, not Wendell. Smith told Webb he had photographs and, "sexually charged convos," between DD and a staff member, a, "lunch lady." The photographs are the ones mentioned above. The, "sexually charged convos," are recordings Smith took of a three-way call between DD and Dawn. Dawn didn't know the recording was taking place.

I have viewed the pictures. The first picture is of a blond female who appears to be in a kitchen. The female has her index finger and a small amount of hair resting on her lower lip, smiling. That image was sent to the various directors of Washington State Juvenile Group Homes, to include Steve Cordero of Parke Creek Group Home, to identify her. Cordero was able to positively identify the female in the picture as the cook at the group home, Dawn McLaughlin.

On 6/3/21 at 1017 hours I obtained an audio/video recorded statement from Chris McLaughlin using the recording equipment at the Kittitas County Sheriff's Office. Chris told me he understood the recording equipment was activated and that the recording of our conversation was voluntary on his part. Chris told me

Dawn called him on Tuesday, 6/1, at approximately 1034 hours. According to Chris, Dawn called him crying hysterically, which is abnormal for her as she is typically a reserved person. Dawn told Chris that she was in, "big trouble," because she had sex with an under aged individual at Parke Creek 2.5 years ago. Dawn also admitted to Chris she had been drinking a lot at the time and had also been drinking at work. (This correlates with my interview of DD on 6/9, who told me the first time he and Dawn kissed was on her birthday, 12/24, and Dawn admitted to him that she had been drinking).

Chris explained that he and Dawn had separated in November of 2020, but that he wasn't sure as to why Dawn wanted the separation. It was Chris' belief the separation would result in the two being able to work on their marriage and stay married. Chris and his son went to Thanksgiving in Montana and when they returned home, Dawn had moved all her belongings out. (This is later seen in a text conversation between Dawn and Jermaine Smith, although Dawn believed she was texting DD). Dawn told Chris she wanted a divorce.

During Chris' conversation with Dawn, she implied that the sexual contact with DD wasn't consensual on her part. Chris added that in his opinion, Dawn would be the type of person who would be easily manipulated. He also believes Dawn contacted him to tell him what she had done, after Parke Creek director Steve Cordero issued her a letter stating there was an investigation against her and took her keys to the facility from her. Dawn also told Chris that someone had texted her, prior to her conversation with Cordero, stating that she was in trouble. It is my belief, at this point in the investigation, that person was Smith, however he has denied the claim. See recorded interview of Chris McLaughlin.

I asked Chris to send Dawn a text message, asking if she would be willing to speak with me, which he did. Dawn responded that she was in the process of retaining an attorney and would not be speaking with me.

Also, on 6/3/21 at approximately 1053 hours I spoke with Wendell Downs Jr, CHILD. CHILD Downs explained he had discovered his son was talking to an individual who appeared older than DD. According to Downs, he was visiting CHILD at the Oakridge Group Home in Tacoma when DD asked him to login to his SnapChat account, using Downs' phone. After logging into the account, Downs observed a picture of a female, unclothed. There is no indication the female was Dawn. CHILD CHILD had no further involvement or knowledge about the case.

I then made phone contact with Steve Cordero. Cordero told me that he was notified of the internal investigation into Dawn on 5/26. Cordero add that on

5/24 (the date was later found to be 5/20), Dawn was at the facility and appeared to be depressed. Cordero contacted Dawn who told him she wouldn't be able to work the following day due to a doctor's appointment. Video footage of Dawn leaving the facility later that day showed that she had collected the personal affects from her office and left. That was the last day she was at the facility prior to Cordero issuing her a notice of investigation and placing her on paid administrative leave. It is believed Dawn knew of the investigation prior to Cordero learning of the investigation and that's why she collected her personal affects. I later obtained video footage of Dawn's office area. Dawn is seen on her phone, texting and reading texts as she is intermittently crying. Dawn is seen packing belongings from the office. Due to the size of the video, it was not placed into Spillman and is being store on my county issued external hard drive. Parke Creek employee Philip Wells told me that the date on the video is correct, however the time is incorrect by 23 minutes. Wells also told me Dawn got a new cell phone and number after she left the facility.

DD was housed at Parke Creek from 10/16/18 through 2/27/19 according to Parke Creek records. DD's date of birth is 8/14/02, making him 16 years old at the time of the alleged incident(s) at the group home.

On 6/8/21 I made phone contact with Katie Becerra. Becerra had previously left me a voice message on my work cell phone, telling me she had pertinent information to this case. Becerra stated she had received a phone call from Dawn on 6/1 at approximately 1400 hours and the two spoke for about 20 minutes. Becerra told me she has been friends with Dawn for approximately 28 years and that she confided in her as to what happened at the Parke Creek Group Home. Dawn told Becerra that she had a sexual relationship with a resident whose name started with a, "D." The sexual contact occurred on four occasions. Dawn told Becerra that she didn't feel the sexual relationship with DD was consensual. Dawn then heard from DD's supposed family, who learned of the sexual encounters, and were demanding money, or they would report the incidents to law enforcement. Becerra agreed to provide me a recorded statement later (6/15).

I then made phone contact with James Webb at Sunrise SCF in Ephrata at 509-754-3121. Webb took the initial call from the person he believed to be **CHILD** **CHILD** however, it was actually Smith (confirmed by Smith). Webb told me that Smith had relayed to him he had located inappropriate pictures and sexually explicit conversations between DD and the, "lunch lady," who was later identified as Dawn McLaughlin. Webb told me he did not view any of the pictures, as they weren't sent to him, nor did he view any of the sexually explicit conversations. Webb told me he forwarded the contents of his conversation with Smith, to the director of Ephrata Sunrise, Mathieu Guettinger. Guettinger wrote

a report that has been attached to the case file. The information was then forwarded to regional administrator Ryan Pinto.

Also, on 6/8 I spoke to Pinto over the phone at 253-686-2878. Pinto told me he received the pictures of Dawn from phone number 206-335-8762 (the phone number I've used to communicate with Smith). Pinto said he called and spoke with the person who identified himself as Wendell Downs. It was Pinto's belief that he was speaking to [CHILD] Pinto sent me a detailed email, describing how he got involved in this conversation and why it was his belief he was speaking to [CHILD] [CHILD] although it appears as though he was actually speaking to [CHILD] [CHILD] Smith (later confirmed by Smith).

I looked up the 206-335-8762 phone number in the law enforcement database, LINX. The phone number was associated with a Jermaine Smith. I made phone contact with the number and asked for Smith, however the person answering the phone stated their name was, "Wendell." Smith later admitted to me that he had answered the phone and that I spoke with him, not Wendell. Smith stated he had spoken to Pinto, "a couple of weeks ago," (5/26). Smith also confirmed he had sent the pictures to Pinto. Smith initially told me he did not have any text message conversation between he and Dawn, however later sent me 15 attachments of screen shots. It is my belief Smith thought he could possibly be in legal trouble for being in possession of the text messages. Dawn was actually having the text conversation with Smith, not DD, because Smith was pretending to be DD via text. Dawn never sent pictures to DD (although she thought she was). The pictures were sent to and received by Smith. In my subsequent interview with DD, he stated he never saw the pictures that were sent to Smith. Smith added that he had voice messages saved that are from Dawn and are sexually explicit. Those voice messages were obtained through the recording of a three-way call between Dawn and DD.

On 6/9/21 I traveled to the Oakridge facility in Tacoma and obtained a digitally recorded statement from DD. Upon arrival I made contact with CPS investigator Stacy Johnson. Due to Chris and Dawn both being employed by DCYF, out of the Ellensburg area, Moses Lake DCYF was asked to be involved in the investigation. The Moses Lake CPS investigator is Lisa Padilla. Due to the distance between Moses Lake and Tacoma, Padilla contacted Johnson and asked that she attend my interview with DD.

DD told me he knew why I was there to speak with him. DD agreed to provide a digitally recorded statement and I turned on department issued recorder at approximately 1325 hours. DD told me Smith received the pictures and text

messages from Dawn because Dawn thought she was texting DD. DD went onto say that Dawn was probably confused because she had messaged him using Facebook Messenger quite some time ago, to include her phone number. DD did not have a phone and Smith text Dawn back with his phone. Dawn believed that was DD's phone number and unknowingly began a text conversation with Smith. DD added he has not seen any of the text messages or the pictures that Dawn sent to Smith.

DD told me he was at the Parke Creek Group Home from either 10/12/18 or 10/16/18 through 2/26/19. DD felt like Dawn, "liked," him and began flirting with him. DD admitted to flirting back with Dawn after she continued to complement him on his looks, to include his smile. DD would help Dawn in the kitchen nearly every day while she was there. According to DD, Cordero and Wells said something to him and Dawn about DD being in the kitchen too much. (In a subsequent conversation with Wells, he recalled DD being in the kitchen more than he needed to be).

DD described the kitchen to me, and later drew me a diagram of the kitchen layout. DD told me there was a very small portion of the kitchen that was out of view of the camera. DD described the area as being similar to the room the interview was taking place in. There is a small area, just inside the door, that was out of camera view. DD told me that every time anything sexual occurred between he and Dawn, it happened in that small doorway area. I estimate that area, at Oakridge, to be approximately 3 foot by four foot. I later went to Parke Creek and found the area DD was describing and estimated the area to be about the same size as the Oakridge area or perhaps even smaller.

DD described the evening of 12/24/18. On that night Dawn came to work to cook for Christmas and told him she had been drinking. DD remembers the day because it was Dawn's birthday and also his niece's birthday. In the spot hidden from camera view, DD said that Dawn kissed him. DD wasn't expecting the kiss because up until that point, the two had just flirted back and forth. DD didn't think the flirting would lead elsewhere and he didn't say anything to Dawn and didn't know what to do. DD said he sought advice from his older brother, but his older brother told him to disregard what had happened.

On 12/28 the two talked about the kiss while they were in the kitchen. During the conversation, Dawn asked DD if she could touch his, "dick." DD believes he was wearing sweatpants and she reached inside and grabbed his penis. DD then said, "To be honest, she sucked it a little bit." DD told me Dawn pulled his pants partially down and performed oral sex on him. Dawn performed oral sex on DD for approximately 15 minutes and then stopped, because she was afraid someone would catch them.

DD told me that all of his and Dawn's sexual contact/intercourse with one another occurred on Fridays. The following Friday was 1/4/19. DD added that the employees at Parke Creek, who worked on Fridays, typically didn't do checks of the kitchen during their shifts, making he and Dawn's interactions easier. DD stated that he and Dawn had sexual intercourse with one another every Friday from 1/4/19 through the time he left, 2/27/19 (it was DD's recollection he left on 2/26). DD was adamant that sex only occurred on Fridays, and that it was every Friday except for two, because Dawn had told him she was on her period.

On 1/4/19 DD said he didn't plan on, nor did he really want to have sexual intercourse with Dawn, because he has a girlfriend. DD explained sex the first time with Dawn as, "she kinda pulled my stuff out and slid it in her." Leading up to sex, Dawn told DD she doesn't have sexual intercourse with her husband and talked down about him a lot. Later in January DD recalled Chris visiting the facility and meeting him. Dawn made a comment to DD that it was weird having two guys in the same area, that she, "Was doing something with."

DD went onto tell me that on 1/4 the two were kissing in the small space and Dawn took DD's hand and put it down her pants. DD stated Dawn wasn't wearing underwear and he put his fingers inside her vagina. It was DD's assumption that was all that was going to happen, but Dawn removed DD's penis from his pants, raised one of her legs up as they stood face to face, and put DD's penis inside her vagina. DD added that the lights were off in the kitchen every time the two had sexual intercourse. With these incidents occurring during the winter months, it would have been dark earlier in the day than the rest of the year. DD said there was never protection used and he orgasmed after having sexual intercourse with Dawn on 1/4 after approximately ten minutes. According to DD, he ejaculated into his hand when he orgasmed. Dawn returned to her office, cleaned herself off, and left work for the day. DD said that sex with Dawn always occurred after dinner and towards the end of her shift, which is 1800 hours.

DD said that after having sex with Dawn for the first time, she told him that she loved him. DD called his brother because he thought he should tell someone. DD's brother told him not to tell anyone because, "That's telling." I asked DD if he reported the sexual conduct to any of the staff and he told me, "No, because I felt like I was going to get in trouble." DD said he didn't tell any staff members at any of the facilities he was housed at, about his sexual relationship with Dawn.

DD remembers Dawn messaging him through Facebook's Facetime through an iPod touch he had access to while he was at Sunrise in Ephrata. DD said Dawn wanted to come visit while he was at Sunrise and try and have sex with him. DD added he

didn't want to see Dawn again. I asked DD why he didn't want to see Dawn again and he told me, "Because it was weird. I mean, it's cool having sex or whatever but I felt like, you know, because I really loved the girl I (inaudible)."

DD told me he was afraid of telling staff what was happening between him and Dawn, after the first time they had sex, because he would get into trouble. DD went onto say, "I felt like I would get into trouble for, like you know, therefore, I don't care, cook or not, you have power. DD was afraid Dawn would claim that he sexually assaulted her if he told anyone about what was occurring between the two.

DD said that after the first time he and Dawn had sex he told himself, "Why not, lets do it, just, so you know, like I said, you don't get in trouble." DD said there were two positions the two had sexual intercourse in, the one described above, and then he said, "From the back." DD said Dawn would sometimes be bent over, in front of him, while the two had sexual intercourse with one another. DD said he ejaculated every time he and Dawn had sexual intercourse. DD's ejaculate would go into his hand or onto his clothing and then he would get a paper towel to clean himself off. DD believes he ejaculated inside Dawn on one occasion and she told him she took, "A Plan B or something." DD added that Dawn reached orgasm most of the times the two had sex and then she would compare DD to her husband. DD said the comparisons made him feel uncomfortable. Dawn would tell DD that when he got out from being incarcerated, she would leave her husband for him.

I reiterated with DD that sex occurred every Friday, except for two between 1/4 and 2/26. Those Fridays are 1/4, 1/11, 1/18, 1/25, 2/1, 2/8, 2/15, and 2/22. Meaning, DD and Dawn had sexual intercourse, to include 12/28, seven times. No sexual contact occurred on the two Fridays that Dawn was apparently on her period with DD stating, "nothing happened, I'm younger, and to this day it still grosses me out I don't even want to be next to a woman if she's on her period."

DD detailed an exchange he had with Dawn, which made him feel more and more as though he needed to try and distance himself from her but told me he didn't know how. Dawn told DD that Steve listens to her and that all she had to do is feed him. Although DD didn't think Dawn was threatening him, he felt like the comment added to the authority she had over him. Another reason DD said he needed to distance himself from Dawn was she kept telling him that she loved him. Dawn also got increasingly jealous of other female staff members when she would observe DD interacting with them. Dawn would confront DD about his interactions with those staff members. I then produced the picture I had been sent, allegedly of Dawn McLaughlin. DD confirmed it was a picture of Dawn, who he had sexual

intercourse with. See digitally recorded interview with DD.

I then returned to Ellensburg and made contact, via text, with Jermaine Smith. Smith confirmed it was him that had been messaging Dawn. Smith then sent me 15 screen shots of text messages between him and Dawn, to include the two previously mentioned pictures.

On 6/10/21 I received a video from [REDACTED] CHILD Jermaine Smith. Due to the file size of the video, Smith had to send it to me in approximate two-minute increments. Smith took the video of a cell phone conversation in which DD was speaking with Dawn during a three-way call. Dawn did not know the recording was being made. The video shows two phone numbers displayed on the screen, one of which is 509-929-3542. I made phone contact with Chris who told me Dawn had recently changed her phone number, but that her old phone number, which fits into the timeframe the three-way call was made, was 509-929-3542.

During the recording Dawn can be heard saying, "Something very very special happened on my birthday two years ago." Dawn goes onto tell DD that, "at that time like I had like love for you." Dawn explains to DD that the feelings she had for him led to her knowing she needed a divorce from Chris. Dawn then tells DD, "so...I just want to be with you so bad." Dawn then says, "...I want to laugh with you, but I want to have fun with you, I wanna like have sex with you." Dawn then explains to DD that she could get into a lot of trouble for what had or was occurring, stating, "we could get into a lot, well I, you'll not get into actually any trouble, it's me, I would get into a shit ton of trouble."

During the same phone call Dawn tells DD that, "I can't contain the crazy when I'm talking to you." Dawn is talking to DD about wanting to be in a relationship with him. Dawn goes onto say, "I was so messed up because I was so crazy about you...and I wasn't like, and it was just like, I knew like, wrong. And it was, I was so fucked up in the head, so I couldn't take advantage...I couldn't be like myself around you."

DD then confronts Dawn about not sending him, presumably, inappropriate pictures. Dawn tells DD, "You know what mister, you know what? You have a special lady in your life who, cause she's not just like, she's reserved and she loves you a lot, and she's also insecure, but she's never going to mess around on you, she's always going to be faithful to you." Dawn goes onto say, "And you're not getting what you want right now, but you're going to have everything that you want when you get out." DD then tells Dawn, "I want to see what I forgot about, you got to remind my memory, refresh it." Dawn laughs at DD's request, again, presumably to send him inappropriate pictures of herself. Dawn

then says, "Dude, I give you those pictures not long ago." DD then adds, "I need an upgrade."

Dawn continues to talk about her insecurities with DD and then says, "I cannot wait, to like, be together, because yes I'm insecure, but I don't, I'm not going to let it hold me back from, like, loving you." DD then asks for pictures again, stating, "You need to refresh my memory," and then brings up what happened on her birthday two years ago. Dawn responds with, "Oh my god, that was um, that was insane, what happened on my birthday." DD then says, "What happened, I don't know, I remember it was the 24th." Dawn replies, "It was on the 24th that I turned 44." Dawn adds, "I got a pretty good birthday present," after DD tells her to explain what happened. Dawn eventually states, "I got your love on my birthday."

Dawn asks if DD and she are speaking using his cell phone and DD lies to her and tells her they are. Dawn briefly sounded worried, then DD jokingly calls her a, "Creep." DD continually asks Dawn to describe their interaction on her birthday two years ago. Dawn eventually asks, "That I got, that I got, your beautiful dick on my birthday?" DD questions Dawn again, telling her he didn't hear what she said and Dawn again replies with, "I got your beautiful dick on my birthday." Dawn adds, "You do have, CHIL you do have a beautiful dick and your balls, I love your fucking balls. Oh my god, I was never into balls until I saw your balls and I'm like, oh my god, those are sexy as fuck." Dawn continually laughs while she's talking to DD about his genitals. That concluded the first recorded conversation between DD and Dawn.

The recording of the second conversation didn't start until approximately 51:57 into the conversation. Dawn is explaining to DD that she doesn't feel comfortable sending him pictures of herself. DD tells Dawn, "Well you did it before, so it wasn't a problem before." Dawn eventually hangs up the phone and a male, the person recording the conversation during the three-way call, can be heard saying hello to DD. See the second recorded conversation between DD and Dawn.

On 6/15/21 Katherine Becerra came to the Sheriff's Office to talk to me about her conversation with Dawn McLaughlin. I activated the recording equipment in the KCSO interview room at 1508 hours. Becerra told me she knew she was being recorded and that the recording of our conversation was voluntary on her part. Becerra stated she has been friends with Dawn for 28 years. On 6/1 Dawn began calling her repeatedly, however she was busy and was unable to talk with her. The two eventually spoke to one another at approximately 1400 hours in a call that lasted about 20 minutes according to Becerra.

Dawn told Becerra she had sexual intercourse with an inmate at the Parke Creek Group Home. Becerra told me Dawn used the inmates name, however she only remembered the name starting with the letter, "D." Dawn began the conversation with Becerra by telling her she had inappropriate sexual contact with an underage kid that was living at Parke Creek. Dawn also told Becerra that the sexual, "contact," took place four times between DD and herself. Becerra added that Dawn admitted to her that the sexual contact was actual, "penis in the vagina," sexual intercourse and that Dawn also admitted to performing oral sex on DD.

Becerra went onto tell me it was her belief that someone from DD's family contacted Dawn and told her they were going to report the sexual conduct between her and DD unless she paid them \$3000. Becerra also confirmed Dawn had gotten a new phone on 5/26. Dawn told Becerra that there, "was an element of manipulation," with regards to her sexual conduct with DD along with force occurring one of the times. Becerra described Dawn stating that while she and DD were engaged in sexual intercourse, DD pushed her back down as she was trying to return to a full upright standing position. It is unknown if this alleged force occurred while Dawn was performing oral sex on DD or whether Dawn was in a position that DD had described to me while the two engaged in sexual intercourse. This was the only incident in which Dawn described any force being used against her during sexual intercourse with DD, however, the way Becerra described the encounter, the two were already engaged in consensual sexual intercourse prior to the alleged force being used. See digitally recorded interview with Katie Becerra.

I had previously asked Cordero for Dawn's timecards from 10/1/18 through the end of February, the rough timeframe DD was housed at Parke Creek. On 6/15 Cordero sent an email to my department email that contained an attachment of Dawn's timecards. After reviewing the timecards, I was able to confirm that not only did Dawn work until 1800, she worked every Friday that DD alleges sexual contact/intercourse occurred between he and Dawn (except for two Fridays in which DD stated Dawn was on her period). See Dawn McLaughlin's timecards, which have been added to the case file.

I had learned through my interview with Becerra that Dawn had retained defense attorney Margie Alumbaugh to represent her. Due to the possible extortion that Dawn explained to both Chris and Becerra, I wanted to give Dawn an opportunity to report the incident, as she would be a victim in that matter. I left a phone message with Alumbaugh on 6/15/21. On 6/16/21 Alumbaugh returned my phone call and stated Dawn had no interest in reporting the extortion at this time.

CONCLUSION:

Dawn McLaughlin was administratively booked on Custodial Misconduct First x7 on 6/22/21.

On 6/3/21 I began an investigation into claims that Parke Creek Group Home Employee Dawn McLaughlin had sexual intercourse with a 16-year-old resident of the facility 2.5 years ago. Dawn works as a cook at the facility and is currently on paid administrative leave.

Dawn admitted to her husband, Chris McLaughlin and a longtime friend, Katie Beccera, that the sexual intercourse occurred. Dawn confided in the two after Jermaine Smith, of Bellevue, reported the allegations. [REDACTED] CHILD [REDACTED] CHILD (DD) is the victim in the assault (Custodial Misconduct First Degree). Statements were taken from Chris and Becerra which included Dawn admitting to Becerra she had performed oral sex on the, "underaged," individual whose name starts with the letter, "D."

Smith learned of the assaults after Dawn began texting him, believing she was texting DD. Smith also has a recording of a three-way conversation in which Dawn did not know she was being recorded. During that conversation Dawn talks about having sex with DD and makes several references to his penis. The recordings have been added to the case file.

DD was housed at the Parke Creek Group Home from 10/16/18 through 2/27/19. Timecards from that timeframe show that Dawn was working at the facility and confirm she was working on the days that DD stated he had sexual intercourse with Dawn. The timecards have been added to the case file.

DD is currently housed/incarcerated at a group home in Tacoma called Oakridge. On 6/9 I traveled to Oakridge and obtained a digitally recorded statement from DD. DD described several sexual occasions with Dawn. Their relationship began with Dawn making comments about DD's looks and soon progressed into more. On 12/24/18, Dawn's birthday, DD stated Dawn had been drinking and kissed him while the two were in the kitchen.

On 12/28/18, DD stated Dawn asked to touch his penis and then she reached inside his pants and grabbed his penis. Dawn then performed oral sex on DD for approximately 15 minutes and stopped because she was fearful of being caught.

From oral sex on 12/28 their intimate relationship developed into penis/vagina sexual intercourse the next Friday, 1/4. DD told me in his statement that he and Dawn had sexual intercourse every Friday from 1/4/19 until his release from the facility on 2/27/19 (except for the two detailed below). Dawn worked a typical Monday through Friday schedule. DD added that he knows he didn't have sexual intercourse with Dawn on two of the Fridays between 1/4 and 2/27 because she was on her period. DD was adamant that the two had sexual intercourse on every other Friday except those two Fridays.

The Fridays from 12/28/18 through the time DD left include 1/4/19, 1/11/19, 1/18/19, 1/25/19, 2/1/19, 2/8/19, 2/15/19, and 2/22/19. Dawn admitted to Becerra that she had sexual intercourse with DD on four occasions and performed oral sex on him. DD stated Dawn and him would have sexual intercourse with her standing in front of him, facing one another, with one of her legs raised up with his penis inserted inside her vagina and also with Dawn facing away from him, bent over at the waist, and DD's penis in her vagina. Protection was never used while DD and Dawn had intercourse. DD told me he ejaculated every time aside from the oral sex incident on 12/28. DD recalled ejaculating inside Dawn's vagina on one occasion, with Dawn telling him she purchased, "a Plan B," afterwards.

Sexual intercourse occurred in a small portion of the Parke Creek kitchen. DD would routinely aid Dawn in cooking and cleaning, which progressed into their intimate relationship. I have toured the facility, seen the camera (2) placement in the kitchen, and also viewed the surveillance monitors and can confirm that there is an approximately 3' by 4' portion of the kitchen, just inside the doorway, that is not covered by the surveillance cameras. This is consistent with the location that DD described to me.

Based on the statement I obtained from DD as well as Chris McLaughlin and Katie Beccera, and the recordings I obtained from Jermaine Smith, I believe that probable cause exists for the arrest of Dawn McLaughlin for seven counts of Custodial Misconduct in the First Degree.

While transporting McLaughlin and during my contact with her I did not ask her any investigative question.

Once at KCCC Detective Sinclair met me and finished the booking process.

NARRATIVE:

I began this investigation after being contacted by Stephanie Frost, an investigator with the Workplace Investigations Unit for the Department of Child Youth and Families. Frost was assigned an internal investigation into Dawn McLaughlin, an individual that is a suspect in a Custodial Misconduct First Degree case that I had previously investigated. Frost told me during her investigation, she made contact with Rachel Baxter. Baxter is a DCYF investigator assigned to the Moses Lake Office.

I made phone contact with Baxter who told me she had information regarding possible sexual assault(s) that took place at the Parke Creek Group Home when she was an employee there from May of 2019 through the time she left in June of 2020. Baxter added she quit working at the facility due to her belief there were sexual assaults occurring at the facility, and there being no repercussions from those allegations.

Baxter explained she had information that three juveniles possibly had sexual relationships with McLaughlin and one other male juvenile had a sexual relationship with a former counselor at the location. I traveled to Moses Lake, where Baxter is an employee at DCYF. I brought a document supplied to me by Frost and provided it to Baxter. The document consisted of five pages and was a summary of a conversation Frost and Baxter had, with Frost typing what Baxter had told her. I supplied the document to Baxter and asked her to review it for accuracy. Baxter wrote several clarifying comments on the document. The document was then signed by Baxter as her statement. I have scanned in the statement and placed it into Spillman.

Baxter told me she had concerns about McLaughlin shortly after she started working at the facility. Baxter was counseling a youth by the name of CHILD CHILD who reported McLaughlin acting inappropriately with several other juveniles to include, CHILD CHILD and CHILD (JM). Baxter didn't know the juvenile's complete names, however through

investigation I was able to find them. CHIL reported the three named juveniles would enter the freezer (where there are no cameras) and kiss and hug McLaughlin. Baxter also suspected McLaughlin of introducing contraband into the facility to include a cell phone and cocaine. This led to two of the youths failing a drug test and escaping the facility.

On 7/28/21 I traveled to the Twin Rivers Community Facility in Richland, where JM is currently being housed. JM had been incarcerated at Parke Creek Group Home from 3/26/20-9/2/20. I had previously made contact with JM's counselor, David Robertson, who told me JM didn't work that day and that 1000 hours would be the best time to speak with him. I arrived at the facility at approximately 1000 hours. Robertson told me JM was suffering from anxiety because I was there to speak with, and he didn't know why. JM was also upset because although I was told he didn't work that day, his schedule had changed, and he was missing work because of my being there.

Robertson led me to a room where I could speak with JM. JM entered the room a short time later and was clearly not happy that I was there to speak with him. JM sat sideways in his chair, arms crossed, and made little to no eye contact with me as I tried to speak with him. I told JM I was there to talk to him about things I was told happened at the Parke Creek Group Home. I told JM it was my understanding he may have had an inappropriate relationship with a staff member, and he told me he had not. I also told JM I was informed that a staff member had possibly aided in getting him contraband inside the facility and he again denied my claim. I then specifically asked JM about McLaughlin. JM told me McLaughlin was a friend to him, was one of the only people at the facility that cared about the youth there, and that she was a good person. JM asked if he could leave the room and I told him he could. JM then left the room.

Robertson and I spoke for approximately five minutes and then there was a knock at the door. JM entered the room and asked that Robertson leave the room. JM sat back in the same chair he previously sat at. This time he sat up to the table, facing me, hands on the table and making eye contact with me. JM told me he was sorry, because he felt he was disrespectful to me and because he knew I had driven from Ellensburg to speak with him. JM reiterated that he believes McLaughlin is a good, kind person, but told me things did happen between he and her that he thought were important for me to know about.

I asked JM if it was okay for me to record our conversation and he told me it was. I activated my department issued recorder at approximately 1027 hours. JM told me he understood my recorder was on and that the recording of our conversation was voluntary on his part.

JM started off by telling me he thought that the Parke Creek facility was a great facility, to include the staff. JM, knowing why I was there, told me things with McLaughlin started as soon as he got to Parke Creek. JM recalled McLaughlin telling him that he was, "handsome," upon his arrival. It was JM's belief at that point, he'd be able to use McLaughlin to introduce contraband into the facility, stating, "trying to have her run it in for me."

JM added he would have someone drop something off for him (outside the facility) and then McLaughlin would bring the contraband inside and place it in the staff bathroom where he could retrieve it. JM told me there was a stand where paper towels were kept in the bathroom and McLaughlin would hide the items she brought in, amongst the paper towels. JM stated McLaughlin introduced cocaine, a "dap pen," a phone, and some eye drops for him. JM said McLaughlin was simply the, "runner," of the contraband, that he would set everything else up. JM and McLaughlin would go on walks on Parke Creek Road. At the end of the county road there is a wide spot for cars to turn around. JM told me his person would hide the contraband in between the slats at the cattle guard at the end of the county roadway. JM would then retrieve the items when he and McLaughlin were walking together. If JM couldn't hide the items on his person, due to the size of the items, he would give them to McLaughlin and she would smuggle them into Parke Creek and then hide them in the staff bathroom for JM's retrieval. According to JM, McLaughlin would know about the contraband ahead of time, because JM would ask her to go on a walk. I later took pictures of the cattle guard at the end of Parke Creek Road. Those pictures have been added to the case file. The cattle guard is approximately 2000 feet from the door to the Parke Creek Group Home.

JM then admitted that he had grabbed McLaughlin's butt on a couple of occasions but told me the two never had sexual intercourse. When I asked him to confirm that the two never had sexual intercourse, JM appeared to become embarrassed, quietly asking, "do I have to answer that?"

JM went onto tell me he and McLaughlin were in, "Wells'," office when the one and only sexual interaction occurred between the two. They were on a computer because McLaughlin was helping JM complete forms for his food handler's card. JM told me there were two computers in the office and the two were sitting at the computer that wasn't the one that Wells would typically use for his daily work. There are no cameras in Wells' office.

According to JM, he was, "in the mood," and expressed his feelings to McLaughlin, who initially dismissed his advances. However, JM told me McLaughlin kept looking at him a certain way and he felt like she was coming onto him, to

include her telling him he was handsome. JM said, "Basically I, I, I whipped out my dick and she just tells me, like, oh, um..." JM was clearly embarrassed about the conversation we were having and was struggling to talk about the sexual contact he and McLaughlin had, so I asked him some direct questions.

JM confirmed he did not have penis/vagina sexual intercourse with McLaughlin, with McLaughlin telling JM to, "put it away," after he had removed his penis from his pants. JM however stated he was turned on due to them, "feeding on each other's energy." The two were still seated next to one another while JM's penis was removed from his pants. JM then began, "grabbing her ass." McLaughlin then performed oral sex on JM by putting her mouth on his penis. Oral sex lasted for approximately three minutes and stopped because McLaughlin was fearful Wells would enter his office. JM added that there was a box of donuts in the office and McLaughlin was feeding JM one of them when Wells walked into his office. This was the only time that the two had sexual contact with one another.

During our discussion, JM brought up [REDACTED] CHILD (JB). JM was completely sure that no sexual contact occurred between JB and McLaughlin. JM told me he and JB were roommates and JB would have told him if something inappropriate had occurred. JM added he knew everything that was happening at Parke Creek while he was there. See digitally recorded statement from JM.

I made phone contact with Frost and updated her on my interview with JM. Frost told me Wells had been placed on a temporary reassignment due to the McLaughlin investigation.

Wells and I spoke for a short period of time before I asked him if he would be willing to provide me with a statement, and he agreed. I activated my department issued digital recorder at approximately 1024 hours. Wells told me he understood my recorder was on and that the recording of our conversation was voluntary on his part.

Wells told me McLaughlin would regularly use his office and the on-call computer that is housed in his office. McLaughlin needed to use the computer so she could help the youth at the facility obtain their food handler's card. Having their food handler's card made it easier for the youth to get jobs after they turned 16 years old and had moved on from the facility. Wells told me Steve Cordero would routinely bring donuts for the staff on Fridays. It was normal for McLaughlin to provide a donut to a youth who had passed the test and obtained their food handler's card on a Friday, when donuts were there.

Wells told me he had no idea that McLaughlin had done anything out of the ordinary while she was employed at Parke Creek, especially rising to the level of my investigation. Wells went onto say he does monitor the kitchen area, via camera, and if he notices a youth in the kitchen longer than he needed to be, he could buzz in and tell them they needed to leave. Wells added he had no knowledge of McLaughlin aiding the youth in introducing contraband into the facility. See digitally recorded statement from Philip Wells.
