**ORDER OF PUBLICATION**

The object of this suit is to enforce the lien of the Complainant, County of Northumberland, Virginia, for delinquent real estate taxes against certain real property located in the County of Northumberland, Virginia, described as follows:

All that certain lot, piece, or parcel of real property lying and being situate in Fairfield Magisterial District, Northumberland County, Virginia, and described as follows:

All of Lot #12, Upper Bay View, containing 1.48 acres, as duly dedicated, platted and recorded among the land records of said County, in Deed Book 295 at Page 434, with the plat of survey thereof being filed in Plat Book 6, at Page 79, and to which reference is made for a better and more accurate description of the property conveyed hereby.

Together with the right to use 0.129 of an acre, located on Lot 8, for use as a remote drain field for Lot 12, and designated as Remote for Lot 12, as shown on said survey recorded in Plat Book 6 at Page 79, among the land records in the Clerk's Office of the Circuit Court in Northumberland County, Virginia. It being understood that the sole interest of grantee in and to the said 0.129 acre, located on Lot 8, shall be for the purpose of using it as a remote drain field for Lot 12 only.




