ORDERED ALLOWED

The County Court is requesting the County Clerk to borrow \$100,000.00 for the Special Road and Bridge Fund on August 8, 1984.

AS A MATTER OF RECORD:

The County Court signed an Order this date concerning duck blinds at Lake Contrary. Order is attached.

ORDER

WHEREAS, Lake Contrary in Buchanan County, Missouri, is the property of the State of Missouri, under the control and custody of the County of Buchanan, State of Missouri; and further it is the responsibility of the Buchanan County Court to administer and maintain the property of Buchanan County and preserve said property for the enjoyment and recreation of the citizens of Buchanan County; and

WHEREAS, it has come to the attention of the Buchanan County Court that certain individuals have placed and constructed duck blinds within the boat channel of Lake Contrary; that the placement of said duck blinds at said locations present a danger to the health and safety of recreational and pleasure boaters.

WHEREFORE, after due consideration and deliberation, IT IS ORDERED, ADJUDGED AND DECREED by this Court that certain regulations be established upon the waters of Lake Contrary; they shall be:

1. The construction of all duck blinds in the boating channel shall be of floatation design and secured by weights sufficient to hold the duck blind in place. The placement of duck blinds of other than flotation construction shall be strictly prohibited.
2. The construction, maintenance, placement or leaving of any duck blinds upon or in the boat channels at Lake Contrary between April 15 and Labor Day shall be strictly prohibited.
3. A fine of \$100.00 shall be assessed against anyone who neglects to remove, permits to remain, constructs, maintains, or places a duck blind upon said boat channels during the proscribed period. A fine of \$100.00 shall be assessed against anyone who neglects to remove, permits to remain, constructs, maintains, or places a duck blind of non flotation construction at any time in or upon said boat channels of Lake Contrary.
4. Any blinds found in or upon Lake Contrary boat channel during the proscribed times or of non flotation construction at any time shall be destroyed at the expense of the owner.
5. Anyone constructing or placing a duck blind in or upon the boat channel of Lake Contrary during the permitted period shall provide a \$100.00 signature bond filed with this Court and its Clerk to assure the proper maintenance and removal of said duck blinds.

So ordered this 1st day of August, 1984.
