PROBABLE CAUSE IS BASED ON THE FOLLOWING FACTS:

On September 19, 2017, Detectives arrested Kenneth Gleason for the murder of Donald Smart and Brue Colfied. During the investigation, Detectives obtained a search warrant in which computer equipment and a notebook were collected. In the notebook, Gleason specifically outlined steps for searching the internet using a system called Tails. Tails is a live operating system that you start from on almost any computer from a USB or DVD. It aims at preserving your privacy and anonymity and helps you to use the internet anonymously and circumvent censorship as all connections to the internet are forced to go through the Tor Network. Tails leaves no trace on the computer you are using unless you ask it explicitly; use state of the art cryptographic tools to encrypt your files, emails and instant messaging.
