POST-ARREST COMPLAINT

Charge 1: SODOMY, 1ST DEGREE
 Charge 2: RAPE, 1ST DEGREE - INCAPABLE OF CONSENT-PHYSICALLY HELPLESS

On June 6, 2021 I was dispatched to a possible sexual assault where two older males had taken a fourteen and two twelve year old females out, and drank alcohol with them and allegedly had sex with one and oral sex with another. Through investigation it was determined that on or about April 24, 2021 that Mr. Cameron had purchased beer and liquor to provide to the females, consumed it and drank it with them on McAmmon Ridge Rd. in Mckee, Ky. Mr. Cameron admitted during a recorded interview that he purchased the alcohol and had one twelve year old perform oral sex on him and he had sexual intercourse with a different twelve year old on the night in question.
