Notice is hereby given that on January 5, 2026, the Cuming County Public Power District (Cuming Co. PPD) filed a petition with the Nebraska Power Review Board seeking approval of proposed amendments to its Charter. On December 15, 2025, the Cuming Co. PPD's Board of Directors approved a resolution stating that the following amendments should be made to the District's charter. For purposes of this Notice only, the proposed language to be added to the charter appears in bold text, while the existing language to be removed from the charter is in (parenthesis). Note: Only the actual changes to the charter language are contained in this notice. Any charter language not included in this Notice will remain unchanged.

The proposed changes to Section IV and V of the District's charter are as follows:

"IV. That the principal place of business of the (proposed) district shall be located at West Point, Nebraska, within said (proposed) district.

V. That the (proposed) district shall have no power of taxation nor to issue general obligation bonds and all property within said district shall be exempt from the levy of any taxes for the payment of any obligations of the district."

Any interested person may file a written protest, complaint, or objection with the Power Review Board in opposition to the approval of the above-referenced proposed amendments. All protests, complaints, or objections must be received in the Board's offices no later than March 6, 2026, by mailing the document to: Nebraska Power Review Board, P.O. Box 94713, Lincoln, NE 68509-4713, or delivering the document to the Power Review Board's offices located at 301 Centennial Mall South, Lower Level, Lincoln, Nebraska. If the Board receives any protest, complaint, or objection on or before March 6, 2026, from a person residing in the Cuming County Public Power District's service area, or any other party affected by the proposed amendment, the Power Review Board will hold a hearing, at which the person filing said protest, complaint, or objection may appear and contest the approval of the district's proposed amendment.

The Board hereby provides notice, pursuant to the Nebraska Administrative Procedure Act, that in the event of a contested hearing, if any party requests that the Board be bound by the formal rules of evidence, all costs of the hearing shall be paid by the party or parties against whom a final decision is rendered. at which hour, or as soon as possible thereafter, the bids will be opened, read aloud, and tabulated, in the presence of all attending bidders to furnish said labor, materials, and equipment broken down to accurately reflect unit prices for all estimated quantities.

There are two separate piping projects at the West Water Plant. Pipe ranging in size from 10" to 30". The

project will include cut in tees, DIP pipe, wall sleeves that will need to be installed, brick, concrete wall cores and disinfection. City will provide the 10" pressure reducing valve and brick for the reaction basin project. The work proposals should include all labor and appurtenances. The work will need to be completed per standard City of Norfolk specs. The 2 projects are described in detail as follows:

Section A: Zone 1/Zone 2 Pressure Reducing Valve(PRV) includes the connection of 24" Zone 1 piping and 20" Zone 2 piping. There will be a 10" pressure reducing valve that will be purchased by the owner and installed by the contractor. Also there will be (1) 24X10X24 live tap, (1) 20" butterfly valve, (1) 10" water valves, tees and (1) manhole for the pressure reducing valve.

Section B: Reaction Basin Outlet consists of connecting an existing 24" DIP pipe to the reaction basin. A 24" pipe will need to be core drilled into the existing reaction basin. The replacement brick will be supplied to the contractor and the contractor will need to install the brick.

Addendums No. 1 thru 5 are not relevant to this project. Plans for Sections A and B are found in Addendum No. 6 for the West WTP Improvements.

All work called for in the plans and specifications shall be furnished in strict accordance with the plans and specifications prepared by the Black & Veatch for the Engineering of the Public Works Department of the City of Norfolk.

CONDITIONS:

1. Contractors submitting bids must visit the site to verify conditions and quantities.

2. All prospective bidders will need to show 5 previous projects within the last 5 years on projects similar in nature to the proposed projects.

Each bid must be accompanied by a bid bond or certified check on a bank whose deposits are insured by the Federal Deposit Insurance Corporation in the amount of 5% of the total bid price and must be payable without condition to the Treasurer, City of Norfolk, Nebraska, as evidence of good faith of the bidder and as agreed liquidated damages in case the bidder whose proposal is accepted by the City of Norfolk fails to enter into contract within ten (10) days from the Notice of the Award or fails to furnish acceptable bond to complete the work and pay for all labor and materials used, said bond to be in the amount of 100% of the total bid price.
