Invitation for Bids

Sealed bids for the construction of South Water Main Loop, Norfolk, NE - 2017 will be received by the City of Norfolk, at the City office at 309 N. 5th Street, Norfolk, NE, until 2:00 pm local time on April 5, 2018, at which time the Bids received will be publicly opened and read.

The project consists of constructing:

Bid Section "A" - Approximately 3,636 lineal feet of 12-inch water main, 175 lineal feet of 24-inch cased boring, 890 lineal feet of 12-inch directional drilled water main, valves, hydrants, air release structures, and all other associated work as indicated on the drawings and within the specifications.

Bid Section "B" - Approximately 6,678 lineal feet of 12-inch water main, 895 lineal feet of 12-inch directional drilled water main, valves, hydrants, air release structures, and all other associated work as indicated on the drawings and within the specifications.

Bid Section "C" - Approximately 2,037 lineal feet of 21-inch sanitary sewer line manholes, services, and all other associated work as indicated on the drawings and within the specifications.

Bid Section "D" - Approximately 1,372 lineal feet of 8-inch water main, valves, hydrants, services, and all other associated work as indicated on the drawings and within the specifications.

Bids shall be on a Unit Price basis.
