Narrative

This complaint is related to a complaint already filed against city councilor Shelly Briggs Loosely who is married to the UCAN CEO in Roseburg Oregon and Shaun Pritchard is the working and full time paid emppoyee CEO of UCAN plus Homeless Commission Commissioner. Summary of Allegations: Mr. Sean Pritchard simultaneously held the position of acting (now confirmed full-time and paid) CEO of UCAN, a nonprofit organization, while serving as a public official on the City of Roseburg Homeless Commission. During this time, he actively promoted, coordinated, and influenced a public process that led to: The City of Roseburg purchasing UCAN's property at 948 SE Mill Street, The renovation of that building using public funds, and The award of a \$3.25 million sole-source contract to UCAN to operate the Navigation Center at that site. Each of these steps directly benefited UCAN financially, while Mr. Pritchard maintained decision-making authority and participation on the public commission overseeing the matter. Key Facts Supporting the Complaint: Mr. Pritchard began presenting the "3-phase concept" (property sale, renovation, operations contract) in late 2021, both to city staff and to UCAN's board (then chaired by Steve Loosley, the spouse of Councilor Shelly Briggs-Loosley). He participated in site tours of the UCAN building and discussions with the city's property acquisition group ("Group of 4") and other officials without recusing himself. He did not recuse from discussions until the January 2022 Homeless Commission meeting — after a conflict-of-interest letter was submitted to city officials. As part of this investigation, it is recommended that OGEC review minutes, recordings, and communications from UCAN Board of Directors meetings during the relevant period. Members of the UCAN Board should also be contacted and interviewed where appropriate to confirm details related to the planning, presentation, and approval of the 3-phase Navigation Center concept, as well as any concerns regarding financial practices including invoice inflation or the handling of grant funds.
