- 1. The assigned officer has been personally contacting these encampments for the past seven weeks.
  - a. On three of his work days, he has been accompanied by ADAPT mental health and/or addiction counselors, who offer assistance and housing services;
    - i. He and the counselors specifically try to engage the unhoused to ascertain if they can connect them to resources to help better their situation;
      - 1. The response has been underwhelming;

- c. ADAPT has also provided each encampment with their version of a resource form.
- 2. The assigned officer initially focused on education;
  - a. He implored the campers to clean up their trash;
    - i. He facilitated getting trash receptacles to encampments and different areas in parks;
    - ii. He worked with local volunteers who helped hand-carry bags of trash from encampments.

3. The assigned officer then transitioned to issuing warnings for Offensive Littering and other various crimes.

- 4. When those warnings were not heeded, the officer began issuing citations.
- The assigned officer has been contacting the campers and advising them our pre-pandemic procedures for enforcing encampments on public property, specifically parks, would be reinstated shortly;
  - a. He was polite and professional, but very clear to everyone that camp postings and cleanups were resuming.
- 6. The first encampment cleanup in 2021 was conducted on July 14<sup>th</sup>;
  - a. Four camps were posted and cleaned up;
  - b. The trash and debris from those four camps filled four 20-yard dumpsters.
- 7. On the morning of Sunday, July 18<sup>th</sup>, the assigned officer posted 16 encampments for cleanup, between Gaddis Park and the grassy area that's behind what used to be Kings Table;
  - a. The below camp posting form is laminated and stapled to a wooden stake that was hammered into the ground directly in front of each encampment (in the most visible area):



#### UNAUTHORIZED CAMPSITE

It is the policy of the City of Roseburg Police Department to provide 72-hour notice before removing personal possessions at unauthorized campsites unless illegal activity is occurring or there is an immediate danger to life, welfare, and/or safety.

Seventy-two (72) hours from the date and time of this notice, the City shall cause the removal of all items. Personal property may be held up to 30 days. Property that is unclaimed after 30 days will be disposed of. Items that appear to have no apparent utility or that are in an unsanitary condition will be immediately discarded. To reclaim personal property or for more information contact the Roseburg Police Department at 541-492-6760, Monday through Friday (excluding holidays) from 8 AM to 4PM.

Law Enforcement has determined that an illegal activity other than camping, an exceptional emergency such as possible site contamination by hazardous or bio-hazardous materials and/or an immediate danger to life, welfare, or safety is occurring. Personal property and unauthorized items have been removed or discarded as described above.

It is illegal to remove this sign without permission from the Roseburg Police Department.

- 8. Photos were taken of the encampments in their current state;
  - a. Photos were taken of the posting notice and its placement.
- 9. UCAN was notified of the locations of the encampments, and date/time of the postings.
- 10. The assigned officer personally re-contacted these encampments several times on the days following the postings, to remind and encourage the campers to clean up their trash and vacate.
- 11. Four of the sixteen posted encampments completely cleaned their campsites and vacated prior to the cleanup date.
- 12. Today, (Wednesday, July 21<sup>st</sup>) Community Development responded with the Douglas County work crew to conduct cleanup;
  - a. UCAN also responded with two social workers to offer housing assistance to the campers;
  - b. At this point campers have had three days to collect their valuables, clean up their trash, and vacate.
    - i. Campers who had not already vacated were given an additional hour or longer to gather their valuables and leave;
    - ii. Trash was discarded in dumpsters;
      - 1. Trash and debris from this cleanup filled six 20-yard dumpsters and the beds of two utility trucks.
    - iii. Items of utility left behind were collected and will be stored for 30 days at the Police Department for safekeeping.
