INITIAL NARRATIVE

Supplemental Narrative

On Friday, March 15, 2019, at approximately 0100 hours, officers were dispatched to Molly's Party Club (309 N. Market), in regards to a fight in progress.

Upon arrival, I, Sgt. Wilson, made my way into the bar. I was directed to the far east side of the bar, by the establishment's staff.

Upon arrival at the east bar area, I observed that Molly's staff had a black male, later identified as Cameron E. Starks (DOB 02-10-2000), detained on the floor, on his stomach. While placing Mr. Starks into handcuffs, bar owner, Michael Hoskey, informed me that Mr. Starks had gotten into a physical altercation with another bar patron. He stated that after he observed Mr. Starks push the other patron, he was taken down to keep the fight from escalating. I then began to escort Mr. Starks out of the bar.

While walking Mr. Starks out of the bar, I was grabbed by the right shoulder, by a black male, later identified as Kylan Harrell. Mr. Harrell was demanding that I release Mr. Starks. I shook Mr. Harrell's hand off my shoulder and directed him to not touch me again. I then continued to escort Mr. Starks out of the bar. I later found that Mr. Harrell had attempted to grab me again and was stopped by PSO Jones, who was also present during this incident. I also found that Mr. Harrell also assaulted PSO Jones, during this incident. See supplemental report.

While outside the bar, I searched Mr. Starks' person, before placing him in my patrol car. Upon locating his wallet, I located his Missouri driver's license, as well as another black male's driver's license. When asked why he had another person's identification, Mr. Starks stated that he used it to get into the bar, as the year of birth on the other male's driver's license was 1995. I then placed Mr. Starks in my patrol vehicle as I attempted to ascertain what had occurred in the bar.

Mr. Starks stated that he and another patron got into an argument, in regards to a female, while in the bar. He stated that there was some mutual pushing, and the next thing he knew, he was forcibly being taken to the ground, by Molly's staff. I later found that the other patron did not wish to file charges of assault, on Mr. Starks. Mr. Starks stated that he did not wish to file assault charges on the other patron. However, he did stated that he may come to Maryville DPS, at a later date, to file charges of assault, on the Molly's employees that assaulted him.

Supplemental Narrative

On Friday, March 15, 2019, at approximately 0100 hours, officers were dispatched to Molly's Party Club, located at 309 N. Market for a fight in progress.

Upon my arrival, I entered the establishment and met with Sgt Wilson, whom had arrived on scene first. Sgt. Wilson had taken a friend of Mr. Harrell's into custody and was attempting to walk him out of the establishment. As Sgt. Wilson was trying to exit Mr. Harrell attempted to stop him from leaving, by placing his hands on him. Sgt. Wilson instructed him to stop touching him and continued to exit the establishment.

As Sgt. Wilson was walking away, Mr. Harrell grabbed for Sgt. Wilson again. When I attempted to stop him, Mr. Harrell slapped my hands away and pushed me in the chest with both of his hands. I told him he was under arrest and attempted to take him into custody. He would not comply with my orders to place his hand behind his back and started fighting with me. After a brief struggle, I was finally able to gain control of him, and with the assistance of other officers, he was taken into custody.

Mr. Harrell was then escorted out of the establishment and transported to Nodaway County Sheriff's Department, where he was placed on a 24 hour hold.
