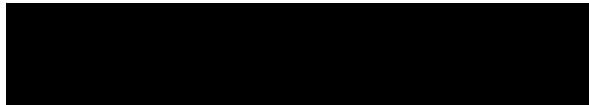

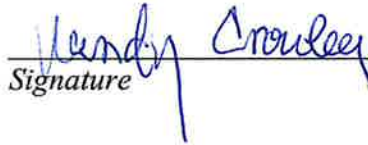

CALIFORNIA'S CONFLICT OF INTEREST LAW

The Political Reform act requires that officials, employees, commissioners, board members and consultants designated in an agency's conflict of interest code disclose their private economic interests and to disqualify themselves from participating in decisions in which they have a financial interest.

The Fair Political Practices Commission has primary responsibility for the impartial, effective administration of the Political Reform Act.

Required Statement of Economic Interest Filings

- Assuming Office: Must be filed with the City Clerk within thirty (30) days after assuming office.
- Annual Statement: Must be filed with the City Clerk no later than the first Monday in April. As a rule, the period covered by the annual statement is January through December of the calendar year.
- Leaving Office: Must be filed with the City Clerk no later than thirty (30) days after the date you leave office.

Failure to File

Government Code Section 91013 imposes a \$10 per day fine up to a maximum of \$100 for the late filing of a statement of economic interest.

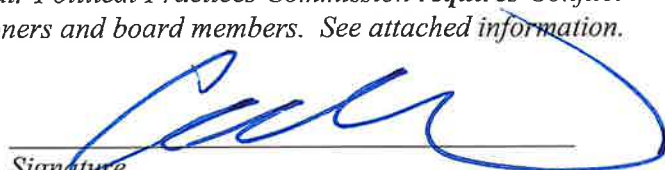
