## I. THE ORANGE BENCH; a poem

#### II. THE IMPORTANCE OF BENCHES:

Benches are far more than just a place to sit; they play a crucial role in creating inclusive, functional, and aesthetically pleasing public spaces.

Here's a breakdown of their importance:

- Promoting Social Interaction and Community: Benches act as gathering points,
   encouraging conversation, spontaneous interactions, and fostering a sense of community
   belonging.
- Enhancing Health and Wellness: They offer a place to rest and relax, promoting physical
  and mental well-being by allowing people to spend more time outdoors and connect with
  nature. Strategically placed benches along walkways or cycling routes can also encourage
  physical activity by providing convenient rest stops.
- Supporting Accessibility and Inclusivity: Benches make public spaces more accessible for people of all ages and abilities, including older adults and individuals with mobility challenges, ensuring everyone can enjoy and navigate these areas fully. For example, they can serve as a 'mobility aid' for individuals with physical limitations.
- Boosting Local Economies: Benches can attract foot traffic and encourage people to linger in areas near cafes, shops, and other businesses, supporting local commerce.
- Enhancing Aesthetic Appeal and Sense of Place: The design and placement of benches can contribute to the visual identity and overall atmosphere of a public space, making it more inviting and enjoyable.
- Supporting Public Safety and Wayfinding: Benches can subtly guide pedestrian traffic,
   create separation between walkways and roadways, and provide visible resting points,
   contributing to a sense of safety and making public areas easier to navigate.

#### IV. PERSONAL STATEMENT:

To the Historic Preservation Committee~

We are a local business that has been active and in good standing way back to 1979. We hire high school students and give them their first paid jobs teaching them responsibility, grit and a sense of pride in work.

We make 85% of our ice creams in-house and feature as many local ingredients as possible. Our ice cream has improved in quality and consistency over the years that we've owned the store (since May of 2021). We use an organic ice cream base and try to use as many fresh ingredients as possible. Ojai Ice Cream is a quality product that the community of Ojai can trust and be proud of.

We took ZERO federal assistance money during the pandemic, stayed open the entire time and kept our employees employed and safe. We are active in our community as well. We support many local teams and charities (including Nordhoff Football, Casitas rowing, the Woman's Club of Ojai, the OVLC, Monica Ros, etc.).

Importantly we have done a HUGE remodel of the store two years ago that we entirely financed. As the store is a destination for tourists (and locals alike), it is an emblem of Ojai and we want it to represent our city and community with pride. The new design of the store has been a welcome change from what it was previously, and we worked hard to develop a design aesthetic and a color palette that both respected the essence of what we wanted the feel of Ojai Ice Cream to be, but also was true to Ojai's spirit. Hence the prominence of orange in our color scheme.


Consistent with the design aesthetic, our interior benches are colored orange as are our low stools. As a business, we have always had seating outside. Previously it was removed nightly and placed back in position every morning. We decided that having something more permanent and structurally sound would be better for the customers and the kids that work in the store and have to move the outdoor furniture. The orange bench that's currently under contention is that more permanent seating piece and we feel it works homogeneously within our design structure and that it holds true to our store's (and Ojai's) essence.

We strongly urge you to reconsider its forced removal. We believe the community wants our bench to remain in place and we'd be happy to start a signature campaign to keep it where it is.

It is **NOT** an obstruction. It is **NOT** an eyesore. It is **NOT** ruining the design aesthetic of the Arcade. It is a happy, orange bench that invites all to sit down and rest. LOTS of customers have

commented on how much they love the orange bench.





We also formally request that we see the "complaint" against the bench that was filed with the City.

Finally, if our bench needs to be removed, then EVERY non design element in the arcade must be removed as well. It feels like we're being targeted. There are unauthorized wine barrels, magazine racks, other seating, etc. littered around the Arcade.
