AFFIDAVIT

Comes now the affiant, of lawful age, in support of a probable cause finding for the detention of the defendant or the issuance of an arrest warrant, states as follows:

1. On Thursday, 3/19/2026, Olathe Police were dispatched to Two Trails Park located at 1000 N Ridgeview Rd, Olathe, Johnson County, Kansas, in reference to an armed disturbance. Initial reports indicated that a male wearing all black, black boots, black trench coat, black hat, and with a backpack, had just stabbed a woman at the park, and was seen running away to the west toward Ridgeview.

2. Officers arrived on scene and found a group of people surrounding Jamie Trumpp, who was seated on the ground on the east side of the picnic table pavilion, adjacent to the parking lot. Jamie appeared to be bleeding from the neck, but alert, conscious, and breathing. Medical personnel arrived on scene to assist.

3. Jamie was transported [REDACTED] for treatment. She had an approximately 5 inch wide, ½ inch deep laceration to the front of her neck. Jamie received internal and external stitches to close the wound. Jamie was required to be admitted to the hospital overnight for observation and continued medical treatment of her

wound

4. Jamie told officers that she remembered sitting at the picnic table and felt a very hard blow to the side of her head. She thought she had been hit by a ball. Jamie said the blow knocked her off of the bench and onto the ground. She said people ran to her screaming and she looked down and saw blood pouring out of her neck creating a pool of blood on the ground.

5. Witness ██████ told police he was at the park with his kids near the pavilion when he observed a male, later identified by officers as KWAN NOBLE TREZVANT, in the vicinity. TREZVANT had approached the pavilion and was acting 'weird.' Based on TREZVANT's behavior, ██████ suggested to others in the area, including a woman with her kid, that they should all leave.

6. ██████ said TREZVANT walked into the grassy area east of the pavilion. TREZVANT then walked back to the pavilion, approached Jamie, yelled "bitch!", and stabbed her. ██████ demonstrated the motion with his right arm as if holding a knife in his hand, with a swinging motion. ██████ saw Jamie drop and start bleeding. ██████ then ran toward the TREZVANT, who fled the area west across Ridgeview.

7. Multiple other witnesses were interviewed by police. Each noted TREZVANT appeared to be acting strange, agitated or aggressive prior to the attack. ██████ was playing tennis with her daughter at the courts near the picnic shelter at the park when she heard someone yelling "get away from there" and "call 911." She saw a woman on the ground surrounded by people and observed someone (TREZVANT) dressed all in black running south of the shelter. ██████ chased TREZVANT at a distance, following

him to Ridgeview to the west. She saw TREZVANT set down a backpack or sweatshirt. He noticed her, then picked up the items and continued running. TREZVANT ran about halfway down the block, then crossed to the south side of the street and ran between two houses. At that point, police were arriving in the area, so she flagged them down and provided directions.

8. Officer Wilkes located TREZVANT seated in a lawn chair in the back yard of [REDACTED]. He was taken into custody. While being secured, TREZVANT made statements to include, "I'm sorry she kept talking to me", "She was calling me names. I asked her over and over again to leave me alone", "I know I'm stupid. I didn't mean to bro, she kept on fucking with me bro" and "She kept fucking with me I had no choice."

9. Officers searched the area and located a knife on the ground between [REDACTED]. The knife appeared to be folded in, which concealed the blade; however, based on the length of the handle was approximately 5 inches long.

10. TREZVANT was transported to the Olathe Police Department for an interview. While TREZVANT was in the interview room, he was yelling or having a conversation with an individual(s) who were not present. He continued to make utterances about the incident and claiming that "you made me stab her", it's the "police departments fault" that "I stabbed her".

11. During his interview, TREZVANT admitted to stabbing Jamie Trumpp in the neck because she (Jamie Trumpp) would not stop "fucking" with him.

12. The above information was obtained from the reports of the Olathe Police Department.
