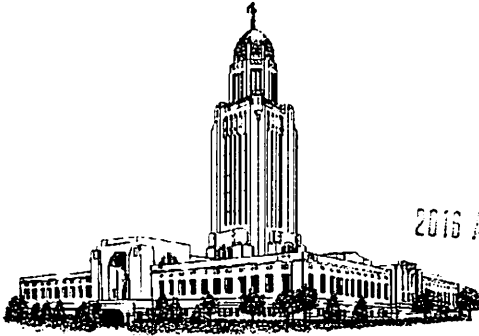

To the NADC,

Since August 11, 2016, Senator Chambers has been misusing government stationary with the letterhead of the Unicameral. While he has every right to contact constituents, contact colleagues and the general public using such materials, he has no right to engage in unlawful and criminal harassment, and continuing such harassment by posting it to Facebook.


As everyone knows by now, Sen. Kintner was subject to an embarrassing extortion attempt. Chambers is continuing to harass Senator Kintner in the most embarrassing manner possible. If this continues, as I expect it will, Chambers will basically be guilty of criminal harassment and subject to a protection order. Chambers can do what he wants, but not with government stationary bearing the Unicameral letterhead and must not do so over social media over the internet.

Senator Chambers is also horrendously ignorant about the use of social media such as Facebook. His postings from either staff or friends likely violate the terms and conditions of Facebook and I have reported him to Facebook officials. He is basically aiding and abetting extortionists, the very kind of extortions which exist on Facebook and contacted Sen. Kintner in the first place.

Who runs his Facebook page at <https://www.facebook.com/Ernie-Chambers-349949081768600/> is unclear but it appears to be a member of his staff. This is hard to determine because Senator Chambers is the only state senator without an email address. This is an issue the "legislative IT director" must address.

I would be happy to defend Senator Chambers' free speech rights, but he has no right to use the imprimatur of the state when his attacks can be viewed as unlawful and criminal harassment of another person, particularly when used in social media such as Facebook. For this reason, I ask for you to take action against Chambers' on this matter. If Senator Chambers wants to air his visceral and unlawful attacks, he is welcome to set up his own blog and do so, but not with the Unicameral letterhead.
