FRANK BARKER EXPLATES HIS CRIME ON THE GALLOWS

Red Cloud Murderer of Brother and Brother's Wife Hanged at the Penitentiary.

His Neck Was Broken and Death Was Instantaneous===He Was Thirty Years Old.

Barker, tried and convicted of the murder of his brother and sis-murder of his brother and sis-der-in-law, died on the scaffold at the last named pro-tor-in-law, died on the scaffold at the last named pro-

kept up a continual fight for his client. The dramatic struggle to evade the death penalty lasted almost four years, and con-tinued until five minutes before the pe-riod designated for Barker's execution

The hours for the execution were between 11 and 3.

Barker was hustled out by the guards at 2:55. He was hurried to the scaffold and prepared for the execution within the minutes.

The authorities feared that complications would arise with his acture attorney if the least delay was encountered. No opportunity was afforded for gal-

No opportunity was afforded for gallows oratory. However, Barker remained fairly calm until the last.



JUDGE IRAAC HASCALL DIES AT HOSPITAL

Passes Away as Result of Stroke of Paralysis a Month Ago-Was Ploneer of Omaha.

Well Known as a Lawyer and Real Estate Man-Came to Omaha in 1865-His Career.

Judge Isaac S. Hascall, one of the best nown ploneers of Omaha, and at one line acting governor of the state of Nebraska, died at 12:45 o'clock this morning at St. Joseph's hospital, where he had been confined for a month with a stroke of paralysis. His end was quiet and peaceful and he passed into the Great

Beyond without a struggle. The funeral arrangements are not yet fully completed, but it is announced that the services will be in the Masonic temple some time Monday. Burial will be in Forest Lawn

York, having been born March 8, 1831, in Eric county. His father, Jonathan Hascall, was a presidential elector from that state. Isaac chose the law and was admitted to the bar at Buffalo in 1853.

In the autumn of 1856 he came west

In the autumn of 1854 he came west in quest of a fortune. Setting first at Fort Riley, Kas., he stayed there over the winter, in the spring went upon into the Little Blue country and then went to Atchison where he practiced law four years. With the ploneer fever in his veins he went to Denver and organized a party for Oregon. Dick Durling, later an Omalia man, was one of the party an Omaha man, was one of the party. They had a hazardous trip to the Pacilite northwest, with all the hardships of overland travel through an unsettled country and frequent fights with Indians. On this trip Mr. Hascall discovered the Big Sinshone falls. Mr. Hascall discovered the

Big Shoshone falls. Mr. Haskall's chief baggage on this trip was a box of law books and for five years he used it in land and mining Higations. He had his full share of fights with outlaws on the boards and bad men in the camps. From Oregon he went to San Francisco, but stayed only a few days and then returned to New York via Panama. To Omaha in 1865.

Again the western fever selzed him and he headed for Omaha of which Darting had told him on the trip west to Den-tor. He reached this city in 1865, bought a building at Fifteenth and Farnam streets, installed his wife there and opened a law office in the Pioneer block. Shortly he was appointed county judge to fill out a vacancy. The next year he to fill out a vacancy. The next year he was elected to that office. He was a member of the Nebraska Constitutional convention and is credited with laying cast the deciding vote in the senate which made Nebraska free soil instead of a slave state. He was acting governor of the state for a few days. He was a measter of the Omaha city council for four terms, twice at large and then as ward considerant Parkers through Parkers ward considerant Parkers through the way were considerant parkers through the parkers thave the parkers through the parkers through the parkers through t councilinan. Between times he was a candidate for mayor, but withdrew in the afternoon of election day seeing that he was beaten, Judge Hascall was influential in city affairs and was the authority to whom councilmen, mayors and all other officials had to fall back upon for knowledge of the city's rights and through this he steered Omaha in its formative days away from many pit-falls. He gave little attention to law after his real estate investments in the south part of the city had grown. He was an optimist in his own speculations and it was commented upon as an melancholy fact that while for the city and state he was usually a wise counselfor yet in his own enterprises he sank a

fortune in putting up three impracticable hotel buildings, each one known in turn as "Hascall's folly" all on South Thirteenth street. He was a man who never spared himself an exertion; he preferred walking to riding; he was rugged in physique, simple in his tastes, and cherished a contempt for men who allowed luxuries of life to lead them away from business. He impeached one governor of Nebraska He impeached one governor of Nebraska

and one mayor of Omaha. His knowledge of constitutional law was second only to that of literature and his familiarity with Shakespeare. In his speeches he was plain and direct. He was a master of invective. He cared little what he said or how when he attacked an opponent and usually any man whom he assailed found it profitable to pay no attention to him if he had a cause that could be defended,

George Robinson of Council Bluffs Instantly Killed While Riding Near Falls City.

Was Well Known in Nebraska and ha-Body at Rulo.

Special Dispatch to the World-Herald. Fulls City, Neb., Jan. 17.-Word was re-ceived here this evening of the death of George Robinson, a well-known representative of the Westinghouse Engine company of Council Bluffs, Ia., which oc-curred at 3 o'clock this afternoon eight miles east of the city.

Robinson was in company with Frank Blakeney of Dawson, this county, and together they were coming west from Rulo in an automobile driven by the latter. In rounding at a lively pace a dangerous turning point in the road. Robinson lost his balance and plunged head foremost from the car. He struck in such a manner that his neck was dis-located. Sheldon declined to make public any part of his interview with Barker, but referred the reporters to Miss Kaup's

Scene in the Cell, The official report of Barker's plea for cromency follows in part, the questions beld, by Governor Sheldon and the an-swers by Barker:




