JOINT DISMISSAL OF CLAIMS WITHOUT PREJUDICE

Plaintiffs Bill Nations and Dick Reynolds ("Plaintiffs") and Defendants the City of Norman and the Cleveland County Election Board ("Defendants") have, by virtue of: (a) the Court's recent grant of Plaintiff's Motion for Temporary Restraining Order; and (b) information provided, through counsel, by Defendants Cleveland County Election Board and City of Norman, regarding statutory and municipal deadlines, come to the mutual understanding that the special municipal election called for by Council Resolution No. 2324-150 procedurally cannot be held on the originally contemplated August 27, 2024, or the next legally permissible Municipal Election date thereafter, November 5, 2024. Bearing the foregoing in mind, Plaintiffs' current requests for relief from the Court are presently moot. Plaintiffs therefore, and with the consent and agreement of Defendants, dismiss their claims without prejudice to their re-filing should circumstances change in the future. The parties, being in agreement in this regard, jointly agree to the filing of this **DISMISSAL WITHOUT PREJUDICE.**





