# Willamina welcomes back comedian Sam Miller

Whenever Sam Miller heads out to take his comedy tour on a West Coast swing, he's now likely to include one of the smallest venues with a growing fanbase here in Polk

Miller is making his third trip to Willamina's Wildwood Hotel Nov. 7.

"I've been all over the WIllamette valley – McMinnville, Dallas, Independence. I started just doing Salem a lot," Miller said. "I love small towns for stand up comedy. The smaller venues, they're doing their own thing. It's a fun thing when they're surprised. Holy moly in Willamina. They don't have to deal with big city problems."

Miller added he just did a show in SoHo, midtown Manhattan and finds its just as equally fun as Willamina.

"Only in Willamina, you don't have to worry about plane tickets or subways," Miller said.

While Miller tours the country now as an award winning comedian, his path to the stage was anything but ordinary. After battling addiction, homelessness, and spending time behind bars, Miller found sobriety and comedy at the same time. Now 15 years sober, he has turned his chaotic past into a fast-rising career. His debut special "Round Trip" hit number one on the iTunes Comedy Chart, and he recently signed a three-album deal with Grammy-winning label Stand Up! Records.

Now residing in Olympia, Washington, with his wife and two kids, ages 12 and 14, Miller said he considers any venue that's within four hours a local show. That's why he's so eager to include Willamina on his itinerary.

"Matthew from the Wildwood loves comedy, and treats comedians well. I love that weird, funky hotel. It's got great food," Miller said. "It's not a big deal to shoot out there. I've come to really enjoy that little town. It's got a decent fan base."

Since he cleaned up his personal act, Miller has been on the comedy circuit for 11 years. He quit his job four years ago to do comedy full



# Dallas changes pickleball, basketball court plans

# New direction to save over \$1 million

The city of Dallas has pivoted in its plans to construct new pickleball courts at City Park and instead transform the existing basketball courts at a substantial savings.

Public Works Director Jennifer Ward presented the option to the city council last week.

She said beginning in 2021, the Parks Advisory Board and city staff had been looking into options to add additional pickleball courts within the city parks system. After considerable engagement with the Parks Advisory Board, Building and Grounds Committee and City Council, in 2024 the City Council

B4 A6 approved a plan to build 10 new pickleball courts in Dallas City Park on the northwest corner of Levens Street and Brandvold Drive. The project would include the excavation and appropriate fill of the old city swimming pool which is buried at the site.

"Staff sought grant funding to offset a project that was coming in at \$1.7 million," Ward explained.

The city first applied for a
Large Local Government Grant
from the Oregon Parks and
Recreation Department with System
Development Charges (SDC) funds
provided as a match. The city did
not receive the grant.

Ward said staff were preparing to go for a second, different type of grant, a Land and Water Conservation Fund grant, with an application deadline of Nov. 17.

"However, one of the capital improvement projects was to resurface the basketball courts at the entry to City Park," Ward said. "As we were preparing to do that, a light bulb went off. This space could accommodate those 10 pickleball courts."

So, Sports Services supervisor Michael Pierce put together a plan and cost estimate for installing pickleball courts. Instead of building

# Non-profit takes over running Indy Days

The city of Independence is handing over the reins of running its annual Independence Days festival to a new non profit composed of community volunteers. The move frees up city staff that were over taxed keeping the three-day event running smoothly.

During his presentation to the City Council, Shawn Irvine, city Economic Development Director, said the plan came from a recommendation by the Independence Days Ad Hoc Commission.

"The Independence Days Ad Hoc Committee was formed to review the Independence Days event and identify how it can be managed with less of a burden on city resources," Irvine said. "The review process provided an opportunity for community input and actively sought comments from residents about how the event could be sustained with less city involvement."

The committee met five times between June and September, interviewing city staff responsible for event operations as well as community members interested in seeing the event continue

Irvine said after thoroughly exploring all viable alternatives, the committee's recommendation is to transfer the Independence Days event to a new community-led 501(c)3 non-profit organization.

"The idea, which I think is actually pretty elegant, is that the community non-profit can take on the event. But if there is a surplus of funds after the event is done, that same non-profit can turn that back into Independence Parks to support the development and upkeep of Independence Parks," Irvine said.

This new non-profit is Friends of Community Parks, whose initial focus is running Independence Days, with a longer-term focus of supporting parks and recreational development within the community.

The staff report described the non-profit's charter, saying in addition to the required board of directors, they would also create a subcommittee, similar to the Independence Days Commission, that is responsible for running the event. The new organization would also take ownership of event-related equipment, contract for insurance and manage any staffing needs to ensure a successful event.

Irvine said the Ad Hoc Committee further recommended that the council use a Memorandum of Understanding to codify the event transfer, identify shared goals, clarify any continuing relationship with regard to the event, and account for the transfer of assets.

He added there are several members of the Independence Days Committee who would continue

# SMART Reading program seeks local volunteers

SMART Reading, Oregon's longstanding children's literacy nonprofit, is calling on local residents to help support and empower young readers. As the organization kicks off its 34th year, it's seeking volunteers to read with local students weekly during the 2025-26 school year.

Volunteers are needed in Polk County at several locations to read one hour a week with students at Lyle Elementary, Oakdale Heights Elementary and the Western Oregon University Child Development Center.

Since 1992, SMART Reading has helped more than 334,000 Oregon children build reading skills and a

lifelong love of books. This year, SMART plans to serve nearly 900 students and give away over 10,400 books in its Northwest region, which includes Lincoln, Marion, Polk and Yamhill counties.

"Our volunteers are the heart of our work," said **SMART Reading Program** Manager Sage Kiernan-Sherrow. "Reading with a child for just one hour a week can ignite confidence, curiosity, and a lifelong love of learning. Volunteers often tell us it's the best hour of their week-and the impact lasts a lifetime."

According to the Oregon Department of Education, 60%

of Oregon third-graders are not reading on grade level.

"Our state is in a literacy crisis," said Kiernan-Sherrow. "All of us have a role to play when it comes to changing Oregon's trajectory and SMART is the perfect way to get involved."

Research and teacher feedback show that nearly 90% of SMART Reading students demonstrate measurable growth in reading comprehension, vocabulary, motivation, and confidence. It's proof that consistent reading time and access to books can change a child's story.

time. Not in his original plans, Miller said he kind of just fell into the profession.

"A friend suggested I do it. I've always been a strange person. I got sober in 2008. I got a lot more funny when I got sober," Miller said. "For folks like me, humor is a life saver. Sometimes I can only laugh."

With influences including the classics of Richard Pryor and new comedians like Sam Tallent and Maria Bamford, Miller said his own brand of comedy is not too dirty, not too clean, but somewhere in the middle.

"I'll talk of the past. Jail, being homeless. The things I'm grateful for. Any of those things and any more," he

Miller considers his brand of comedy safe for just about anybody. One thing he won't joke about is politics.

"It's not something I do," he said. "It's a special time to be a comedian. Because the audience has the opportunity to come out and whatever they're going through, I give them a break from that."

The reviews are glowing for Miller's act.

"His shows are a mix of hilarious true stories with sharp punchlines and real heart. Whether he's talking about being a father, recovery, or what it's like to be 6'6" and 360 pounds in a world built for average-sized people, audiences walk away laughing," read one.

Miller said he has a simple career goal for his life as a comedian.

"If this is as good as it gets, fantastic. It would be fun to have bigger opportunities. But I just want to get in front of

as many crowds as I can, get opportunities where I can," Miller said. "I don't go around begging for opportunities. I go where people want me. They

want me in Willamina." He added for this trip, he's bringing along fellow comedian Pual Goodwin from

Mississippi. "I can't wait for fans to see Paul," Miller added.

Miller performs at 7 p.m. Nov. 7 at The Wildwood Hotel, located at 150 NE Main St., Willamina. The Wildwood is advertising the event as an all-you can eat taco night, with Miller as the opening act. To purchase tickets, call (503) 876-7100 or visit the hotel. The event is considered for ages 21 and older only. The set is anywhere from 45 minutes to an hour.

of the total cost. But the federal grants come with more "hoops" to jump through, so Ward anticipated if granted, the city wouldn't be able to begin construction of the pickleball courts until the summer of 2027.

So, she sought guidance from the city council whether to pursue this alternate path

Engagement with the pickleball club, the basketball players and getting feedback from the public for this plan. Then bring the results back to the Parks Board in December for a recommendation to bring to the City Council," Ward said.

However, she added, pursuing that path misses the window for applying for the grant to fund the original path.

The total cost of the alternate plan is about a third of the original plan.

"Even if we got a 50/50 grant for the original plan, and

even if the city pays for all of the alternate plan, it is still less than the original plan," she said.

Ward clarified the new courts would be solely for the use for pickleball. The plan would be to remove the pickleball striping from the tennis courts at Roger Jordan Park and restore those to full tennis court use.

City Manager Brian Latta explained the feedback the city received from the pickleball and tennis communities was that "the additional lines to play both sports on the same courts sounds good in theory. But in practice it adds a lot of confusion, especially if you're learning either sport for the first time."

The total estimated cost to build 10 new pickleball courts on the south side of Brandvold Drive and two new basketball courts on the north side of Brandvold Drive at City Park is \$501,400. The Dallas Pickleball Club has committed to donating \$10,000 towards the project. The remainder of

the project costs (\$491,400) will be paid from Parks SDCs.

Councilmember Carlos Barientos clarified the city could get a \$700,000 savings from not needing to dig up an old swimming pool at the old location and repave over the construction.

Ward confirmed the new configuration for two basketball courts would not overlap the old pool location. The total savings would be \$1.2 million.

Councilmember Kim Fitzgerald said she appreciated Ward pursuing the alternative

"The other plan was a lot of money. I feel like this is a huge savings. It's just a much better plan," she said.

Councilmember Michael Holsapple expressed concerns that neither plan provided for facilities at the Brandvold end of the park.

"If there is going to be any use of 10 pickleball courts for any events, or anything, people would have to walk all the way to the other end of

the park to find any facilities," Holsapple said.

He preferred a plan that had less courts and room for

His colleague, Michael Schilling, estimated that building new facilities for the 10 new pickleball courts would add an additional \$150,000 to the cost and displace at least three or four courts. He recommended revisiting adding facilities in the future as needed and bringing in Port-o-Potties for big events or tournaments in the meantime.

Latta said the asphalt and rock base are already done on the basketball courts. They still need an acrylic coating on top for the courts themselves (which requires warmer weather), benches and fencing.

"Facilities could be built with SDS funds three or more years down the road," he added.

The council gave Ward the guidance she needed to pursue the alternate plan without needing to take a vote.



### Alan Fredric Oppliger March 6, 1932 - Oct. 7, 2025

Alan F. Oppliger passed away on Oct. 7, 2025, at the age of 93. He was born in Columbus, Nebraska, on March 6, 1932, to Elmer and Vera (Kluck) Oppliger.

In 1942, Alan's family moved to Portland, Oregon, where they worked in the shipyards building Liberty Ships. As World War II drew to a close, his parents opened a Western Auto store in Independence in 1945. Alan attended local schools, earned the rank of Eagle Scout, and began his lifelong passion for running during high school. He continued competing at the University of Oregon under legendary coach Bill Bowerman and was a member of the Sigma Phi Epsilon fraternity. He graduated from Independence High School in 1950 and from the University of Oregon in 1954.

Following graduation, Alan served two years in the U.S. Air Force in Texas. He later returned to Eugene to pursue his MBA but soon moved back to Independence to help his father operate the family's Western Auto store after his mother's passing in 1958. In the late 1970s, he sold the business and began a 30-year career in real estate, earning the nickname "The Running Realtor."

Alan was a devoted supporter of the Independence and Monmouth communities. He served on the Independence City Council and was active in the Chamber of Commerce, Jaycees, Elks, and Rotary. Alan was one of the organizers for the "On to Oregon Cavalcade" in 1959 – the 100th anniversary of the covered wagons which traveled from Independence, Missouri to Independence, Oregon. He helped organize the annual 4th of July Mini-Marathon and numerous other local running events.

An accomplished runner, Alan completed over 10 marathons — including the Boston Marathon — along with several half-marathons and hundreds of 5K and 10K races. He and his wife, Jayne, enjoyed participating in races around the world, including the World Masters Games in Eugene, Melbourne, and Edmonton.


Alan is survived by his wife, Jayne; children, Eric, Leslie, and David; as well as numerous grandchildren and great-grandchildren.

A tear will be shed on the open range of Eastern Oregon as one of its greatest cowboys and Jack-of-all trades rode off into the sunset at the age of 90. Dr. Jack C. Rye finally decided to call it a day, as he passed away on Sept. 5, 2025, in his home



of over 50 years, surrounded by family and dear friends in Monmouth, Oregon. He fought to the end, proving an adage he loved to quote, "Getting old ain't for sissies!"

Cowboy, husband, father, grandfather, leader, mentor and friend were roles he filled in a life well-lived and a one that was much appreciated by everyone he embraced along his trail

Dr. Jack Clinton Rye was born April 4, 1935, in Paducah, Kentucky.

As a child, Jack spent countless hours exploring the Mingo River in Missouri and enjoying the outdoors. He eventually moved to Oregon with his aunt and uncle and graduated from Prineville High School. Jack attended Eastern Oregon State College where he met the love of his life, Grace Fumiko Furuyama.

While in college, Jack acted in the western movie, "Pillars of the Sky." Because of his riding skills and youthful good looks, Jack was asked to move to Hollywood and become a western actor. In this moment, Jack showed his unwavering devotion to Grace, and chose her over potential Hollywood stardom. Jack and Grace bought a house in La Grande, Oregon, where they raised and showed Appaloosa horses, and started a family.

They moved to Corvallis where Jack achieved his Ph.D at Oregon State University. Jack, Grace and their family then moved to Monmouth, Oregon, where Jack became the Director of Graduate Programs at Oregon College of Education. Jack lit up young minds for decades as a respected educator, Head of the Physical Education Department, and Athletic Director at Western Oregon University (formerly OCE). Jack was the NAIA District II Athletic Director of the Year 1986-87. His focus was to help his students, coaches, community so he pioneered the Wolf Pack Auction to raise money for the WOU athletics. Jack started, and was the advisor for, the Eastern Oregon and Western Oregon Rodeo Club teams. He also served in the National Guard.

In retirement, Jack continued to pursue his true passion, riding horses. Jack was a genuine cowboy, spending time on the open range herding cattle, taking his pack mules with friends to the Minam mountains or trail riding with his family. Jack became a competitive team roper, which he continued until the age of

Jack devoted over 65 years to the Lions Club. He chaired the Scholarship Committee for many of those years, again investing his time, talents, and treasure in the success of young people's lives. Jack was widely respected and he received the Lions International President Award in recognition of his outstanding service

Jack loved music and taught himself to play the ukulele. During family gatherings, Jack would play and sing his way through the holidays.

Most important of all to Jack was his family and the extraordinary, deep friendships he cultivated over the years. Jack's life was a journey defined by the rare and wonderful combination of grit and kindness, lifelong bonds, and a selfless servant who supported his countless friends, community and dear family, through to the very end.



Jose will be deeply missed, but his spirit will live on in the hearts of all who knew and loved him.


#### Jean Claire Mann March 10, 1943 - Oct. 3, 2025


### County taxes are wrongfully prioritized

# WOU's orientation program helps retain students

Western Oregon University is celebrating the successful completion of its annual Destination Western program, with nearly 160 students participating and successfully transitioning into university

Destination Western is an immersive, all-expenses-paid 10-day residential program tailored to equip students with essential skills for success in college-level writing and mathematics while fostering social connections. Participants engage in smallgroup academic sessions, workshops, and a variety of social events throughout the

This year's cohort comprised 95 first-generation college students, 22 transfer students, and 130 first-year students. The program also offered a range of excursions designed to enhance connections and enrich the overall student experience.

First-year and first-generation student Nathan Jaggar shared that his favorite part of Destination Western was the social aspect, and added that he's met some cool friends. First-year student Melany Tornez added that she loves the WOU community and how close the cohorts became during the program.

Among the highlights was an excursion led by Western's President Jesse Peters, who guided students through the state capitol grounds in Salem, followed by a visit to the local Farmers Market and a meal at a nearby restaurant.

"It was important to me to be directly involved with this program," said Peters. "I wanted these new students, and all of our students, to know that Western is a place of belonging and empowerment, where we place students at the center of everything we do. These future leaders are an inspiration to us all."

After the culmination of Destination Western, these students joined the rest of the incoming class at PACK (Prepare, Advise, Connect, Know) Welcome Week, a

series of orientation activities designed for admitted students. Throughout the week, current students participated in a variety of activities to help them become more familiar with WOU, including Fingerprint Like a Forensic Investigator to How to Succeed in Math and Science, Ballroom Dance for All, and Financial Literacy.

Other highlights included the annual New Student Sunrise and sidewalk signing tradition, where students come together at dawn to sign their names into university history. Later that day, students attended Prof-Panels with faculty from their academic divisions. Every division was represented, and more than 425 individual new students participated in these valuable conversations about their academic paths.

"Each year, Destination Western brings new excitement to campus and serves as a reminder that at our core, what we at WOU bring most to this world is a strong sense

of community," said Megan Habermann-Guthrie, director of New Student and Family Programs. "From our faculty and staff engaging meaningfully with the new students in and out of the classroom, to the student peer advisors creating memories through homegrown murder mystery parties and games of family feud, I felt honored to witness the nearly 160 new Wolves grow into their new identities as college students."

Destination Western remains an essential program for new students at Western, nurturing connections and a sense of belonging as they begin their academic journeys. This initiative also plays a significant role in student retention. In the fall of 2024, participants in the program achieved an impressive 97 percent retention rate from their first fall term to their first winter term, surpassing non-participating students by seven percentage points.

# INVESTIGATING THE BIBLE: Serenity in suffering

The Serenity Prayer is a tradition in the Alcoholics Anonymous organization: "God, grant me the serenity to accept the things I cannot change, courage to change the things I can, and wisdom to know the difference."

One man in the Old Testament learned serenity through painful life setbacks. Joseph was one of the 12

sons of Israel.

"Now Israel [also called Jacob], loved Joseph more than any other of his sons, because he was the son of his old age. And he made him a robe of many colors. But when his brothers saw that their father loved him more than all his brothers, they hated him." (Genesis 37:3-4,

English Standard Version used

Joseph was more despised when he tattled to his father a report of his brothers' shoddy work and he unwisely shared two dreams, where Joseph was the ruler to whom his brothers and father would bow down.

Three times, Joseph suffered greatly. Jacob sent 17-year-old Joseph to check on his brothers, who were supposed to be watching flocks near the town of Shechem. Joseph found them 20 miles to the north.

"They saw him from afar, and before he came near to them they conspired against him to kill him. They said to one another, 'Here comes this dreamer. Come now, let us kill him and throw him into one of the pits. Then we will say that a fierce animal has

devoured him, and we will see what becomes of his dreams." (Genesis 37:18-20).

Rueben, the eldest, had his brothers throw Joseph in a pit without his multicolored cloak, and no food or water, planning to rescue him later. When Rueben was gone, the brothers sold Joseph into slavery to Midianites traveling to Egypt.

In Egypt, Joseph was sold to Potiphar, a captain of Pharaoh's armies. Evil struck again. Potiphar's wife lusted for Joseph, but he didn't yield. She eventually lied, claiming Joseph tried to rape her. He was cast into a prison, however "...the Lord was with Joseph and showed him steadfast love and gave him favor in the sight of the keeper of the prison." (Genesis 39:21).

The last injustice came from a fellow prisoner. A former cupbearer of Pharaoh had a puzzling dream. God gave Joseph the correct interpretation; the man would be restored to his honored position. The man promised he would remember Joseph, however, "...the chief cupbearer did not remember Joseph, but forgot him." (Genesis 39:23).

Two years passed. Pharaoh had troubling dreams which no one could interpret. The cupbearer finally remembered Joseph and he was rescued from prison. God gave Joseph the interpretation of Pharaoh's dreams.

"Pharaoh said to his servants, 'Can we find a man like this, in who is the Spirit of God?'". (Genesis 41:38).

Joseph became the ruler to save Egypt and neighboring Israel

Tommy Herr was a professional baseball player with the St. Louis Cardinals. He was a solid hitter and a skilled second baseman with a near perfect fielding percentage of .989. He expected to end his career with the Cardinals. However, at age 32 and after nine years with the team, manager Whitey Herzog, who had been like a second father for him, called him to his office.

Edward Grinnan in The Promise of Hope, wrote that Whitey said, "You've given everything we've asked of you, Tommy, [but] we need more power in the lineup. We've traded you to the Twins...". Tommy was devastated "...and it hurt, really

hurt." In his first game with the Minnesota Twins, he got on base

Still upset, his wife suggested he read the story of Joseph. Herr was amazed. "Wow! ...[Joseph] lost everything, including something he wore proudly, his many-colored coat, just like I lost the Cardinal uniform I wore so proudly...maybe too proudly. We don't always control what happens to us, or what other people do. I keep reminding myself of that. We control our reaction."

# Wolves take fourth straight with 34-27 victory at Texas A&M-Kingsville

The Western Oregon football team won its fourth game in a row and took sole possession of second place in the Lone Star Conference with a 34-27 win over Texas A&M-Kingsville on Saturday at Javelina Stadium.

The victory moves the Wolves to 6-2 overall and 5-1 in the Lone Star Conference - one game behind No. 8 Central Washington which moved to 6-0 in LSC play and 7-1 overall with a convincing win at Midwestern State (who WOU plays at home next Saturday). The two lone Division II West Coast teams finish the regular season against each other Nov. 15 - though there's plenty of football between then and now.

WOU trailed the Javelinas (3-5, 2-4) 20-19 at the half before a key third quarter for the Wolves changed the game.

WOU got things rolling with a 10-play, 65-yard scoring drive that included a key 20-yard, third-down run by quarterback Jordan McCarty and was capped

by McCarty 5-yard touchdown pass to Keyvaun Eady (on third down). A two-point conversion (McCarty to Eady again) made it 27-20 Wolves with 8:30 left in the third.

TAMUK got a big return on the ensuring kickoff and an 11-yard run on its first play to move the ball into WOU territory, but Malik Ross intercepted a pass for the Wolves and returned it 42 yards to the Javelina 25 to set the WOU offense up in great position.

Five plays later, Carson Workman rushed for his second score of the game to make it 34-20 WOU with 4:57 left in the third as the Wolves held on from there.

WOU rushed for 216 yards as a team - averaging 4.8 yards per carry with McCarty leading the team with 92 yards to go along with throwing for 180 yards and two scores. Jermaine Land rushed for 44 yards, Terayon Sweet rushed for 28 yards and a touchdown, Workman finished with 21 yards and two scores and Cyris Taylor had 18 yards on a pair of carries.




