I have previously been employed as a law enforcement officer with the Florence Regional Airport and the Lexington County Sheriff's Department. I have received police officer certifications from the Pennsylvania Municipal Police Training Academy and the South Carolina Criminal Justice Academy. I have earned a Master of Criminal Justice Degree from the University of South Carolina, a Baccalaureate Degree in Criminology/Pre-Law from Indiana University of Pennsylvania, and have attended additional classes regarding varying aspects of investigations. During the course of my law enforcement career, I have interviewed thousands of persons regarding their knowledge of criminal activity.

Based on my training, experience, and specific knowledge of this incident, I have come to know the following:

1. On December 8, 2015, at approximately 1542 hours, the Aiken County Sheriff's Office Dispatch Center received a call to respond to 2570 Green Pond Rd. in Jackson, Aiken County, South Carolina, for a well being check. The complainant provided that she observed blood inside when she attempted to make contact with the residents at the left side door.
2. Chief Rushton of the Jackson Police Department was the first to respond to the residence and observed the blood inside as well. Chief Rushton stated that the complainant informed him that one of the residents was Louis Cochran, an employee of Lowes, who had not shown up for work for three days. Louis Cochran reportedly lived at the residence with his wife, Sandra.
3. Chief Rushton forced entry through the side door and observed a blood trail and what appeared to be [REDACTED] shell casings throughout the house. He followed the blood trail to find a white female, deceased [REDACTED]. Lying next to the female is a deceased brown dog that suffered unknown serious trauma. [REDACTED]
4. A 2002 red Mitsubishi Eclipse Spider convertible with tan top belonging to Louis and Sandra Cochran was found missing from the property.
5. Based on the available information, a search of the premises of 2570 Green Pond Rd. in Jackson, Aiken County, South Carolina, is necessary to collect evidence of the crimes committed.
