The Court received eight separate petitions for rehearing. After careful consideration of the petitions for rehearing, the Court finds no material fact or principle of law has been either overlooked or disregarded for the following petitions for rehearing on the arguments listed below. Accordingly, the following petitions for rehearing are denied as to those arguments.

1. The Vestries and Churchwardens of the Parish of St. Andrew (Charleston)
  - a. Issue I
2. St. Luke's Church, Hilton Head
  - a. Issues II and III
3. Trinity Church of Myrtle Beach
  - a. Issues II and III
4. The Vestry and Church Wardens Of The Episcopal Church of the Parish Of Christ Church (Mount Pleasant)
  - a. Denied in its entirety

On the remaining arguments, the Court requests The Episcopal Church (a/k/a, The Protestant Episcopal Church in the United States of America) and The Episcopal Church in South Carolina submit a return to the petitions for rehearing addressing those arguments. Those arguments are: (1) revocation based on subsection 62-7-602(a) of the South Carolina Code (2022), and (2) no trust was created because the language purporting to constitute accession existed in the bylaws or constitutions before 1979. The following petitions for rehearing are included within this request:
