During the course of the investigation Deputies were advised the incident occurred on the bus while in transit to their respective bus stops. Teeple was observed on the video footage stating, " Let know I am going to kick his dad's ass." After which he

I contacted James Teeple and advised him that Principal Condon, Deputy Vecchione and I had reviewed the video footage. I advised James Teeple that School Administration and the Charleston County School District were conducting their own independent investigation separate from the Charleston County Sheriff's Office and advised him that in accordance with the Family Educational Rights and Privacy Act, FERPA, I could not divulge information collected during their investigation to him.

I then gave James Teeple a friendly reminder concerning South Carolina Code of Laws Section 59-67-245 which states the following: No person shall willfully and wrongfully interfere with the operation of a school bus, either public or private, by boarding, restricting movement or using threats, either physical or verbal, to the driver or any passenger while the bus is engaged in the transportation of pupils to and from school or any lawful school activity or while passengers are entering or leaving the bus nor shall any person willfully fail or refuse to obey a lawful order of a school bus driver relating to the occupancy of a school bus. The use of threatening, obscene or profane language addressed to the driver or any passenger entering, leaving or waiting for a school bus is disorderly conduct and any person convicted for the use of such language shall be punished as provided in Section 16-17-530. Nothing contained herein shall be interpreted to infringe upon the power and duties of duly constituted authorities.

James Teeple advised he did not step on the bus and wanted to speak with me concerning the investigation being conducted by School Administration and the CCSD, which I advised him was outside my purview and violated FERPA. James Teeple stated he would include the Charleston County Sheriff's Office in his lawsuit which encompasses the bus company, Angel Oak Elementary, Charleston County School District, etc.

I was able to make contact with some sometimes oncerning the incident and advised her of our findings concerning the video footage. Nothing Further.
