NARRATIVE

(James Island)

On June 13, 2023, at approximately 1945 hours, I, Deputy Johnson was dispatched to 1223 Stone Post Road on James Island in Charleston County. The call was in regards to an animal bite.

Upon arriving on the scene and activating my body worn camera, I made contact with Ronald Wiggins. Ronald stated that a coyote had broken through his fence and tried to attack his wife Ammellia Wiggins. He stated that there dog got in between the coyote and his wife and that the coyote bite his dog in total three times. The dog was bitten on the face, chest plate and back. Ammellia had already taken the dog to the emergency vet to get checked out. Ronald stated that he fired at the coyote a total of three times. Upon looking around the backyard he fired four times. Ronald asked if he would be in any trouble for shooting the coyote. I advised Ronald that he shot the coyote in his yard defining his wife and dog and that he was justified in killing the coyote. The Wiggins wanted to know if the coyote had rabies. I advised Ronald that I could not make that call if the coyote had rabies or not but Animal Control could make that call. The Wiggins did want Animal Control to come out and taken possession of the dead coyote. I advised Ronald that Animal Control could come out tomorrow to pick up the deceased coyote because it was after their work hours.

Animal Control was scheduled to come out on June 14, 2023 to take possession of the deceased coyote. Animal Control did respond around 0900 hours on June 14, 2023 to take possession of the dead coyote.
