

Personally appeared before me, one PFC L. BILES who, first being duly sworn, deposes and says that

DINAH MARIE CHOLLET

did within this town, county and state on 2/10/2026, violate section 16-17-490 of the criminal laws of the State of South Carolina in the following particulars:

**DESCRIPTION OF OFFENSE
CONTRIBUTING TO THE DELINQUENCY OF A MINOR
VIOLATION OF SECTION 16-17-490**

The affiant states that there is probable cause to believe that the defendant named above did commit the crime set forth, and that such probable cause is based on the following facts:

That on February 10, 2026, while at 208 E. 5th North Street, located in the town, county, and state aforesaid, the defendant, one Dinah Marie Chollet, did willfully, unlawfully, and knowingly violate statute 16-17-410 of the South Carolina Code of Laws, (1976) as amended, **CONTRIBUTING TO THE DELINQUENCY OF A MINOR**, in that the defendant did encourage and influence students of Summerville High School to walkout of school during school hours causing a disruption, being truant, and make threats of violence, thus knowingly and willfully encouraging and aiding the juvenile to violate laws.

Facts to establish the aforesaid are that the defendant entered a chat titled Summerville Walkout. The chat is a known chat group for Summerville High School students between the ages of 14-18 organizing an Anti-Ice Protest that would disrupt the school day. The defendant appeared in the chat under the Instagram Handle "theknotburgerpub," and identifying herself as Dinah Yo. The defendant is a known business owner of The Knot Burger Pub. The defendant is 41 years old [REDACTED] and communicated with juveniles to influence and approve of their protest. The defendant stated she was proud of the students involved and that a group, including herself, would be joining the protest. The defendant then stated she wanted to enter the chat with her personal account since she was using the business account and the alerts were coming through the business speakers and stated, "Lets talk about how to make this the BEST." The defendant sent another message and then deleted the content. The defendant shared comments from her personal Facebook account in the group chat, influencing the juveniles to make threats of vandalism and violence against a specific person. Juveniles in the group chat were excited to have Dinah involved, and thanked her for support. The defendant was identified by SCDMV as Dinah Marie Chollet. PFC Biles is a witness to the same. All of which is against the form of the statute in such cases made and provided.
