Below is the data we have on coyote sightings and interactions for the month of August 2023, to-date. We are showing 12 total reports of coyotes; nine (09) interactions and three (03) sightings.

<u>Date/Time</u>	<u>Sighting or Interaction</u>	<u>Location</u>	<u>Description</u>
8/12/23; 0701	Interaction	Not Listed	Caller left a message about two coyotes that approached her dog
8/15/23; 0850	Sighting	Breach Inlet Bridge	Caller reported seeing a coyote on the bridge with foam coming from mouth
08/17/23; 0713	Interaction	Station 23 Beach	Two coyotes chased the complainant and her dog, then retreated to dunes
08/17/23; 0724	Interaction	Station 26 ½ Beach	Two coyotes followed a complainant at the water's edge. Complainant's dog chased the coyotes
08/21/23; 0800	Interaction	Station 26 Beach	A coyote attacked a dog and attempted to carry it off before being confronted by a beachgoer
08/21/23; 0802	Interaction	Station 29 Beach	A coyote attacked a dog on the beach then walked away. Dog not injured
08/23/23; 0750	Interaction	Station 26/27 Beach	Two coyotes attacked two different dogs on beach at water's edge
08/23/23; 0826	Sighting	Station 26 Beach	Two coyotes seen on beach
08/26/23; 0643	Interaction	Station 27 Beach	Two coyotes attacked a small dog and carried it off. *Incident report filed (OCA 23-00246)

08/27/23; 0833	Sighting	Station 25 Beach	Coyotes reported on beach
08/27/23; 2122	Interaction	Station 18 Beach	A coyote attacked a dog near the water line
08/27/23; 0836	Interaction	Station 25 ½ Beach	Two coyotes stalking people on beach
