On 11-22-85, complainant stated she awoke at approximately 10:00 a.m. Complainant noticed her four year old son was not in the residence. Complainant stated she then checked outside the residence, with negative results. Complainant then checked with relatives and neighbors who related they did not see Jeremy. Complainant stated it was odd that Jeremy would have been outside because of the severe inclement weather. On this date, Complainant believes Jeremy was wearing blue jeans, no shoes, and an unknown shirt, if any. Sheriff Heath had all off duty personnel respond to the scene for a thorough search of the area. The Sheriff also requested assistance from the F.B.I. and the South Carolina Law Enforcement Division. A ground and air search was conducted with negative results. Tracking dogs were also used in the search. Two large ponds near Jeremy Grice's residence were checked by divers and later drained also with negative results. The entire subdivision was canvased for any possible leads. All leads were followed through also with negative leads. Family members were questioned several times and also many were polygraphed with negative results. Approximately one week later ground and air searches were conducted again, with negative results. All media and newspapers were requested to publicize this missing child as much as possible. Posters of the child were made up and circulated. The child was placed into N.C.I.C.
