Narrative

On 2/9/2026 I, PFC L. Biles, was working as School Resource Officer (SRO) at Summerville High School (Town of Summerville, Dorchester County, State of South Carolina). An anonymous student wanted to make me aware of a planned protest titled "Summerville Walkout" that was going to occur on February 20, 2026. The protest was publicized on Instagram and was an open account that could be followed. I have a "burner" account to conceal my identity and joined the group. I was a member in their group chat, which also had approximately 80 other members at the time. The group was stated to be organized by Summerville High School students (ages 14-18). I was able to positively identify several students based off their Instagram accounts as Summerville High School students.

I was monitoring the group chat the evening of 2/9/2026 and the morning of 2/10/2026. The organizer concealed their identity and stated they wanted to get as many students as possible to walk out of the school on February 20, 2026 as an Anti-ICE protest at 1310. The organizer wanted to make it known the plan was to disrupt school but remain peaceful. The students stated they thought the administration would be too lazy to process any disciplinary actions. Members of the chat continued to talk to spread the word to make their "walkout" bigger than other schools in the area. Members of the chat continued to talk about possible actions by administrators and law enforcement in the school. [REDACTED] proposed bringing pepper spray "just in case," [REDACTED] stated it may be needed to use against police since protesters have been getting shoved to the floor and it could possibly happen at school. [REDACTED] stated she wanted to bring a comb that has a secret knife for protection, or she may just bring a bunch of keys to use like wolverine claws. Several members stated they hated the police and continuous "Fuck the Police" remarks. The organizer also stated they hated the police but demanded a peaceful protest. There were several members in the chat that were aggressive.

[REDACTED] entered the chat and engaged with a member who promoted opposing views than the groups purpose. [REDACTED] stated " I hope trump gets shot one dat in the fucking head because that what he deserves." [REDACTED] continued to state " I don't give a flying fuck hope he dies with nobody by his side." "Kill trump, Kill trump." I contacted FBI Task Force Officer Mizell to pass the information for threats on President Trump. I notified my Lieutenant of the threats of weapons and against President Trump.

I was positively able to identify [REDACTED] from their Instagram account and PowerSchool (a program used at the school to include the student's photo and demographic information).

I continued to monitor the group chat on the evening of 2/10/2026. The owner of The Knot Burger Pub, Dinah Chollet (identified herself as Dinah Yo), entered the chat designed for students of the High School and engaged in conversation. Dinah introduced herself from the business Instagram account (theknotburgerpub) and stated "We are proud of yall!" Members of the chat began asking if The Knot was protesting with them. Dinah responded, "Oh, theres a group of us that will be out there with you." Members of the group expressed excitement and thanked them. Dinah continued to share comments from her personal Facebook page of her defending the students involved, encouraging them for their behavior. Dinah continued to speak in the group chat about adults who may be at the protest. Dinah shared screenshots from her Facebook account. Dinah's opinions as a prominent business owner bears influence, both direct and indirect over the members of the group to engage in disruptive, truant, and violent behaviors. Juvenile, identified as [REDACTED] engaged with Dinah after multiple comments were made and shared for opposing views. Dinah's influence and engagement by sharing comments from her personal page encouraged [REDACTED] to make threats of violence and vandalism against [REDACTED]. Dinah requested in the group chat for the members to accept her personal Instagram account so she could continue to assist in the protest. Dinah stated she was using the business account and the alerts were coming through the business speakers. Dinah stated, "Lets talk about how to make this the Best."

[REDACTED] was using the Instagram account [REDACTED] and was engaged on the group chat. [REDACTED] made threats of violence and vandalism against [REDACTED]. Based off jurisdiction, this has been reported to Dorchester County Sheriff's office for charges of Unlawful Communication.

I have maintained open dialogue with Summerville High School Administrator, Dr. Michelle Leviner, and Dorchester District 2 Office Personnel. Summerville High School agreed to pursue charges on the threats of weapons on school campus. A victim's form was signed.
