

## **A RESOLUTION**

**TO IMPOSE A ONE PERCENT (1%) EDUCATION CAPITAL IMPROVEMENTS SALES AND USE TAX WITHIN BERKELEY COUNTY PURSUANT TO THE EDUCATION CAPITAL IMPROVEMENTS SALES AND USE TAX ACT, SUBJECT TO APPROVAL BY REFERENDUM; TO DESIGNATE THE SPECIFIC EDUCATION CAPITAL IMPROVEMENTS TO BE FUNDED WITH THE PROCEEDS OF THE SALES AND USE TAX; TO PROVIDE THE MAXIMUM TIME FOR WHICH THE TAX WILL BE IMPOSED; TO ORDER A COUNTY-WIDE REFERENDUM APPROVING THE IMPOSITION OF THE SALES AND USE TAX; TO PRESCRIBE THE CONTENTS OF THE BALLOT QUESTION IN THE REFERENDUM; AND OTHER MATTERS RELATING THERETO.**

**BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE SCHOOL DISTRICT OF BERKELEY COUNTY, SOUTH CAROLINA, AS FOLLOWS:**

**SECTION 1. Findings.** The Board of Education (the "Board"), the governing body of The School District of Berkeley County, South Carolina (the "School District"), hereby finds and determines as follows:

(a) The Education Capital Improvements Sales and Use Tax Act (the "Act"), codified as Title 4, Chapter 10, Article 4 of the Code of Laws of South Carolina 1976, as amended (the "Code"), authorizes certain school districts within the State of South Carolina as specified in Section 4-10-470 of the Code to impose a one percent sales and use tax within the county in which such school district is located to fund specific education capital improvements for the school district, either directly or to service general obligation debt incurred by the school district for such improvements, or a combination thereof.

(b) Section 4-10-425(A) of the Code provides that the sales and use tax authorized by the Act (the "Sales and Use Tax") may be imposed in the county upon the adoption of an approving resolution by the board of trustees of the school district, and the subsequent approval of the imposition of the Sales and Use Tax by referendum open to all qualified electors residing in such county. The approving resolution must specify (i) the specific education capital improvements to be funded with proceeds of the Sales and Use Tax, either directly or through general obligation bonds repaid from proceeds of the tax or a combination thereof, (ii) the period, stated in calendar years, not to exceed fifteen years, for which the Sales and Use Tax may be imposed, (iii) the date of the referendum, and (iv) the question to appear on the referendum ballot which shall include each specific education capital improvement included in the resolution.

(c) The Board has determined, after due investigation, that certain capital improvements are necessary within the School District and finds that it is in the best interest of the residents of the School District that such improvements be funded, either directly or through the payment of debt service on general obligation debt incurred for such improvements, or a combination thereof, from the proceeds of the Sales and Use Tax.

(d) The Board further finds that Berkeley County (the "County") qualifies as a county in which the Sales and Use Tax may be imposed pursuant to the requirements of Section 4-10-470 of the Code.

(e) The Board has now determined to adopt this Resolution to impose the Sales and Use Tax authorized by the Act upon the subsequent approval of the imposition of the Sales and Use Tax by referendum open to all qualified electors residing in the County (the "Referendum"), to designate the

specific education capital improvements to be funded with proceeds of the Sales and Use Tax, and to specify the period of time for which the tax may be imposed, the date of the Referendum, and the question to appear on the Referendum ballot.

**SECTION 2. Imposition of Sales and Use Tax and Designation of Education Capital Improvements.** Pursuant to the authorization of the Act and subject to approval by Referendum as set forth in Section 4 below, the Board hereby imposes a one percent Sales and Use Tax to fund the following education capital improvement projects, whether directly through expenditure of the proceeds of the Sales and Use Tax, through the payment of debt service on general obligation bonds issued by the School District to fund such capital improvements from the proceeds of the Sales and Use Tax, or a combination thereof:

1. Construction and equipping of a K-8 school in the Nexton area;
2. Construction and equipping of a K-5 school in the Jedburg area;
3. Construction and equipping of a K-8 school in the Highway 52 Corridor;
4. Renovation, expansion and equipping of Berkeley High School;
5. Renovation, expansion and equipping of Cane Bay High School;
6. Renovation, expansion and equipping of Goose Creek High School;
7. Renovation, expansion and equipping of Hanahan Middle School;
8. Upgrading Athletic Facilities at Berkeley High School;
9. Upgrading Athletic Facilities at Cane Bay High School;
10. Upgrading Athletic Facilities at Cross High School;
11. Upgrading Athletic Facilities at Goose Creek High School;
12. Upgrading Athletic Facilities at Hanahan High School;
13. Upgrading Athletic Facilities at Philip Simmons High School;
14. Upgrading Athletic Facilities at Stratford High School; and
15. Upgrading Athletic Facilities at Timberland High School

(collectively, the “Education Capital Improvements”).

**SECTION 3. Duration of Tax.** Subject to approval by Referendum as set forth in Section 4 below, the Sales and Use Tax authorized herein shall be imposed for a period of seven calendar years, terminating, if not earlier, on December 31, 2029.

**SECTION 4. Ordering of Referendum.** The Board hereby orders the Referendum on the question of the imposition of the one percent Sales and Use Tax for a period of seven calendar years for

the purpose of funding the Education Capital Improvements to be held at the general election on November 8, 2022, which is a general election meeting the requirements of Section 4-10-425(A) of the Code.

**SECTION 5. Referendum Question.** The form of the question to appear on the Referendum ballot shall read substantially as follows:

**BALLOT QUESTION**

**EDUCATION CAPITAL IMPROVEMENTS SALES AND  
USE TAX ACT REFERENDUM FOR BERKELEY COUNTY**

Must a special one percent sales and use tax be imposed in Berkeley County for not more than seven years with the revenue of the tax used to pay, directly or indirectly, the cost of the following education capital improvement projects in Berkeley County:

1. Construction and equipping of a K-8 school in the Nexton area;
2. Construction and equipping of a K-5 school in the Jedburg area;
3. Construction and equipping of a K-8 school in the Highway 52 Corridor;
4. Renovation, expansion and equipping of Berkeley High School;
5. Renovation, expansion and equipping of Cane Bay High School;
6. Renovation, expansion and equipping of Goose Creek High School;
7. Renovation, expansion and equipping of Hanahan Middle School;
8. Upgrading Athletic Facilities at Berkeley High School;
9. Upgrading Athletic Facilities at Cane Bay High School;
10. Upgrading Athletic Facilities at Cross High School;
11. Upgrading Athletic Facilities at Goose Creek High School;
12. Upgrading Athletic Facilities at Hanahan High School;
13. Upgrading Athletic Facilities at Philip Simmons High School;
14. Upgrading Athletic Facilities at Stratford High School; and
15. Upgrading Athletic Facilities at Timberland High School

All revenue received from the sales and use tax will be used to pay the costs of the education capital improvement projects described above and to pay debt service on general obligation bonds, if any, issued by The School District of Berkeley County to fund the education capital improvement projects described above.

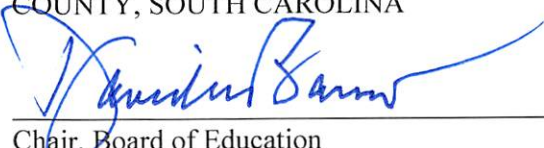
Those voting in favor of the question shall mark the oval beside the word "Yes", and those voting against the question shall mark the oval beside the word "No".

**SECTION 6. Election Authority.** A certified copy of this Resolution shall be filed with the Berkeley County Board of Voter Registration and Elections (the "Election Authority") which shall be requested to conduct the Referendum on the question of the imposition of the Sales and Use Tax in the County substantially in the form of the question set forth in Section 5 hereof, and the Election Authority is hereby requested as follows:

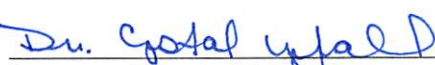
- (a) To join in the action of the School District in providing for the publication of a Notice of Referendum in substantially the form attached hereto as Exhibit A;
- (b) To arrange for polling places for each precinct within the County;
- (c) To appoint Managers of Election;
- (d) To conduct the Referendum, receive the returns thereof, canvass such returns, and declare the results thereof;
- (e) To certify the results of the Referendum by resolution and within ten days thereafter file the resolution with the Clerk of Court for Berkeley County and with the South Carolina Department of Revenue; and
- (f) To take other steps and prepare such other means as shall be necessary or required by law in order to properly conduct the Referendum.

**NOTICE OF REFERENDUM**

**EDUCATION CAPITAL IMPROVEMENTS SALES AND  
USE TAX ACT REFERENDUM FOR BERKELEY COUNTY**

NOTICE IS HEREBY GIVEN that a Referendum will be held in Berkeley County, South Carolina (the "County"), on November 8, 2022, for the purpose of submitting to all persons qualified to vote in the County, under the laws of the State of South Carolina, the following question:

Must a special one percent sales and use tax be imposed in Berkeley County for not more than seven years with the revenue of the tax used to pay, directly or indirectly, the cost of the following education capital improvement projects in Berkeley County:

1. Construction and equipping of a K-8 school in the Nexton area;
2. Construction and equipping of a K-5 school in the Jedburg area;
3. Construction and equipping of a K-8 school in the Highway 52 Corridor;
4. Renovation, expansion and equipping of Berkeley High School;
5. Renovation, expansion and equipping of Cane Bay High School;
6. Renovation, expansion and equipping of Goose Creek High School;
7. Renovation, expansion and equipping of Hanahan Middle School;
8. Upgrading Athletic Facilities at Berkeley High School;
9. Upgrading Athletic Facilities at Cane Bay High School;
10. Upgrading Athletic Facilities at Cross High School;
11. Upgrading Athletic Facilities at Goose Creek High School;
12. Upgrading Athletic Facilities at Hanahan High School;
13. Upgrading Athletic Facilities at Philip Simmons High School;
14. Upgrading Athletic Facilities at Stratford High School; and
15. Upgrading Athletic Facilities at Timberland High School

All revenue received from the sales and use tax will be used to pay the costs of the education capital improvement projects described above and to pay debt service on general obligation bonds, if any, issued by The School District of Berkeley County to fund the education capital improvement projects described above.

Those voting in favor of the question shall mark the oval beside the word “Yes”, and those voting against the question shall mark the oval beside the word “No”.

The question is being submitted pursuant to Title 4, Chapter 10, Article 4 of the Code of Laws of South Carolina 1976, as amended, and a resolution of the Board of Education of The School District adopted on August 9, 2022. If a majority of the qualified electors of the County voting in the Referendum approve the imposition of a one percent sales and use tax in Berkeley County for not more than seven years, such sales and use tax will be imposed in Berkeley County for not more than seven years for the purpose of funding the education capital improvement projects listed above.

Every person offering to vote must be at least 18 years of age on the date of the Referendum, must reside in the County and must be duly registered on the books of registration for the County as an elector in the precinct in which he or she resides and offers to vote on or before the date on which said books of registration are closed for the Referendum, and must present his or her registration certificate or valid South Carolina driver's license or other form of identification containing a photograph issued by the South Carolina Department of Motor Vehicles, if not licensed to drive.

Any person wishing to vote in this election must register to vote no later than Friday, October 7, 2022, in person, or no later than Sunday, October 9, 2022, if registering to vote online, by fax or email. Voter registration by mail forms will be accepted if postmarked by Tuesday, October 11, 2022.

Voters will be asked to provide one of the following Photo IDs at their polling place.

- S.C. Driver's License
  - Includes standard License and REAL ID
- S.C. Department of Motor Vehicles ID Card
  - Includes standard ID card and REAL ID
  - Includes SC Concealed Weapons Permit
- S.C Voter Registration Card with Photo
- Federal Military ID
  - Includes all Department of Defense Photo IDs and Veterans Affairs Benefits Card
- U.S. Passport
  - Includes US Passport ID Card

If you have one of these Photo IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false. Any registered voter can visit an early voting center in Berkeley County and vote on the dates and at the times announced by the Berkeley County Board of Voter Registration and Elections for such early voting.

Voters who are blind, who are otherwise physically handicapped, or who are unable to read or write are entitled to assistance in casting their ballot. This assistance may be given by anyone the voter chooses except his employer, an agent of his employer, or an officer or agent of his union. The Managers of Election must be notified if assistance is needed. Voters who are unable to enter their polling place due to physical handicap or age may vote in the vehicle in which they drove, or were driven to the polls. When notified, the Managers will help voters effectuate this curbside voting provision. Registered voters may be eligible to vote by absentee ballot. Persons wishing more information concerning absentee balloting should contact the Berkeley County Board of Voter Registration and Elections at (843) 719-4056.

The Berkeley County Board of Voter Registration and Elections shall hold a hearing on ballots challenged in the election on Friday, November 11, 2022, at 10:00 a.m., at the office of the Berkeley County Board of Voter Registration and Elections, 1003 US Highway 52, Moncks Corner, South Carolina. The process of examining the return-addressed envelopes containing absentee ballots will begin at 9:00 a.m. on November 7, 2022.

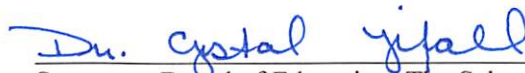
