THE JOE DIMAGGIO CHILDREN

THE DEFENDANT WAS TRANSPORTED TO THE NMBPD STATION TO BE INTERVIEWED. PRIOR TO BEING ASKED ANY QUESTIONS, THE DEFENDANT WAS READ IS MIRANDA RIGHTS PER NMBPD FORM. THE DEFENDANT ACKNOWLEDGED HE UNDERSTOOD HIS RIGHTS AND WAIVED HIS RIGHTS AND ELECTED TO SPEAK WITH DETECTIVES.

THE DEFENDANT ADVISED THAT ON TODAYS DATE, HE AND THE VICITM ARRIVED AT HIS PARENTS RESIDENCE LOCATED AT 17251 NE 2ND AVENUE IN THE CITY OF NORTH MIAMI BEACH, MIAMI DADE COUNTY, FLORIDA, 33162.

THE DEFENDANT ADVISED THAT UPON ARRIVING AT THE LISTED LOCATION, HE HAD HIS FIREARM, A BLACK SIG SAUER .45 CALIBER HANDGUN PLACED IN HIS WAISTBAND. THE FIREARM WAS LOADED WITH A ROUND IN THE CHAMBER.

THE DEFENDANT STATED THAT

THE DEFENDANT ADVISED THAT HE CONTACTED THE POLICE AND WAITED UNTIL OFFICERS ARRIVED OUTSIDE OF THE RESIDENCE.

THE DEFENDANT DID LEAVE A LOADED FIREARM UNSECURED AND UNHOLSTERED WITHIN REACH OF HIS SON WHO WAS ABLE TO TAKE POSSESSION OF THE FIREARM AND SUBSEQUENTLY SHOOT HIMSELF ON THE RIGHT SIDE OF THE HEAD. THE DEFENDANT'S ACTIONS ARE DEFINED BY THE CULPABLE NEGLIGENCE STATUTE IN THE STATE OF FLORIDA. THE DEFENDANT EXIBTED NEGLECIECE AND FAILURE TO PROTECT HIS SON AND THUS, CAUSED GREAT BODILY HARM TO HIS SON.
