Building Board of Adjustments and Appeals (BBAA): Meets as needed. Due to legal advertising and staff requirements, please plan a month in advance.

Planning Commission (PC): Application deadline is the following business day after the previously scheduled PC meeting date by 5:00 pm, excluding City holidays, to include fees paid, documents submitted, and application approval given by the Zoning Administrator. Failure to have a complete submittal may result in the case being deferred.
