Placing an ad

Once you send your legal ad, a representative from our team will reach out to you to confirm receipt. You will receive an ad proof. Once that is approved, you will receive a payment link. Payment must be received before the deadline to run the ad. If you plan to send multiple ads, we can work with our accounting department to set up a credit account for you.

After the final date of publication, we will process your affidavit, which includes the publication dates, the newspaper in which the notice was printed, a visual copy of the published ad, and a notary stamp with clerk signature. The original affidavit will then be mailed via USPS to the address on file. Please allow 1–2 weeks from the final publication date for delivery.
