NARRATIVE

(Pineiland, Hollywood) On 05-07-15, Reporting Deputy (R/D) responded to the above incident location in reference to a burglary in progress with shots fired. R/D was advised by Dispatch that two black males wearing camo pants, armed with guns were breaking into a residence and had fired shots. R/D was the first unit to arrive on scene and advised Dispatch to give him emergency channel. R/D made contact with an elderly black male subject and asked him if he had called 911 and he stated no, but informed R/D that he had heard gunshots and saw two black males go behind a residence. R/D asked which residence it was and was advised that it was the beige and white residence that backed up to the woods. R/D waited for Deputy Powell to arrive on scene before he approached the residence. Once Deputy Powell arrived he and R/D proceeded towards the incident location and as we approached, R/D observed a large bullet hole in the large picture window on the right front of the residence. R/D and Deputy Powell proceeded to draw our service weapons as we cleared the outside of the residence. We cleared around the residence to the rear and Deputy Powell observed that the rear door to the residence was kicked in. R/D and Deputy Powell proceeded up the stairs of the porch to the back door. As R/D stepped onto the porch, the back door swung open quickly and a black male appeared and pointed a handgun at R/D and Deputy Powell. R/D discharged his service weapon at the black male who was pointing a handgun at myself and Deputy Powell. The subject then shut the door to the residence and R/D pushed open the door and found the subject on the ground with a gunshot wound. I saw that the subject was no longer holding the handgun and I holstered my service weapon and began to render aid to the subject, until EMS arrived. Nothing further at this time.
