## SLED CHARGES SPARTANBURG COUNTY MAN WITH TWO COUNTS OF FILING A FALSE POLICE REPORT FOR A FELONY

Agents with the South Carolina Law Enforcement Division (SLED) charged Craig Ninja Antonio Brewton, 35, with two counts of Filing a False Police Report for a Felony on Monday, March 11, 2024. SLED was requested to investigate by the Spartanburg County Sheriff's Office.

Brewton booked at the Spartanburg County Detention Center.

The case will be prosecuted by the South Carolina Attorney General's Office.

## **Arrest Warrants**

Victim: Deputy

The defendant, Craig Antonio Ninja Brewton Jr., did willfully and unlawfully violate South Carolina Code of Law: Section: 16-17-722, Filing a False Police Report, by entering the Spartanburg County Sheriff's Office on October 20, 2023, and reporting a knowingly false felonious incident to law enforcement. Brewton falsely reported a formal complaint against Spartanburg County Deputy that alleged he physically and sexually assaulted Brewton's person during an arrest on September 19, 2022. Through investigation it was determined Brewton's statements were false. The Affiants' belief is based on SLED investigation (34-23-0141). This incident occurred at 8045 Howard St. Spartanburg, SC 29303, at the Spartanburg County Sheriff's Office.

Victim: Deputy

The defendant, Craig Antonio Ninja Brewton Jr., did willfully and unlawfully violate South Carolina Code of Law: Section: 16-17-722, Filing a False Police Report, by entering the Spartanburg County Sheriff's Office on October 20, 2023, and reporting a knowingly false felonious incident to law enforcement. Brewton falsely reported a formal complaint against Spartanburg County Deputy that alleged he physically and sexually assaulted Brewton's person during an arrest on October 18, 2023. Through investigation it was determined Brewton's statements were false. The Affiants' belief is based on SLED investigation (34-23-0141). This incident occurred at 8045 Howard St. Spartanburg, SC 29303, at the Spartanburg County Sheriff's Office.

## **Additional Facts:**

- Brewton filed the formal complaints in person and was provided with the official document, an SCSO Complaint Report. The SCSO Complaint Report contained a disclaimer of "I understand that knowingly making a false complaint is a violation of South Carolina Code Section 16-17-722 and/or Section 16-17-725.
- On December 7, 2023, S/A Clamp met with Brewton and his Attorney, Jennifer Wells. Brewton provided an additional written statement to SLED and was advised any false statements made during the investigation could lead to his prosecution. Brewton both verbally and physically acknowledged S/A Clamp then proceeded to provide a written statement consistent with the one given to SCSO on October 20, 2023.
- On October 4, 2023, Brewton provided a "Demand Letter" to SCSO for \$444,000,0000
