



Women Who Sought & Received Treatment in Guam














What village do you reside in?







Treatment Barriers that Women Experience

- 1) Child Care
 - a) Especially when entering a residential program
- 2) Limited Bed Space
 - a) Only 12 residential beds at Oasis EmpowermentCenter
- 3) Reliable Transportation

- 4) Lack of Support At Home
- 5) Education
 - a) Do not know what treatments are available to them
- 6) Testing & Identification
 - a) Must obtain a skin test, TB test, identification first
 - Some are unable to pay or do not own forms of identification

How Can These Barriers Be Addressed?

- Treatment centers can provide vouchers for testing and provide assistance with acquiring identification
 - Offered at Guam Behavioral Health & Wellness Center's New Beginnings but funding is very limited
- > Another residential care center
- Hiring more certified female peer specialists
 - Would help give a woman's perspective on the process of treatment
- group residential home for families (women with children)
 - day care component

What available services do women feel work best? What improvements can be made?

- > Treatment that provides "Holistic Approach"
 - Working with not just drugs and alcohol issues
 - Working with spirituality
 - Working with drama
 - Working with case management
 - Lacking resources

What are some things that prevent women from seeking treatment?

- > Inadequate childcare
- > Fear of family telling their business to everyone
- > Lack of a support system
- > Emotional abuse from partner
 - Relationship where partner is controlling
 - o Partner has negative impact on their self-esteem
- > Women are held to a higher standard by society than men (ex. children are solely the woman's responsibility)
- ➤ Parents/family (of daughters) prevent them from going to treatment. They do not want the family name to look "bad"

Are there any influences that prevent women from seeking treatment?

- > Family image may be of more importance
- > The environment they're in and the homes
- > No childcare centers for their children to go, because it may be costly
- > Feel pressure from family and society due to society's expectations of a mother
- ➤ Abusive relationships could have a negative impact on self-esteem
- > Stereotypes regarding women who seek treatment

What stigmas do women experience in the community?

- Assumed that women trade sex for drugs, women are belittled and labeled as "chronic" when impacted by drugs/alcohol
- > "Women should not be addicted to drugs, only men"

What may be major differences in treatment between women and men?

- > Women have underlying issues that made them use in the first place
- Women are held to a higher standard because men can't show weakness
- Going into treatment can be perceived as weakness
- A relationship where both are doing drugs/alcohol can be a little difficult when one person wants to recover sooner than the other.
- One person believes that recovery is harder for women because they're more emotional, however men can be just as emotional as women.
- Coed group can be difficult because the emotions may make the opposite genders feel uncomfortable.

Does Guam have adequate access to services?

- > Services are adequate quality wise but not quantity wise
- > More women are wanting to access treatment
- ➤ Always room for Improvement and more that women can benefit from
- > Many qualified service providers but not enough services
- No stable transportation hinders adequate access to services

What Keeps Women Motivated to Continue or Stay In Treatment?

- > Admitting that there's a problem
- ➤ The "WHY"
- Recognizing that they're in treatment for themselves
- *For Mothers* The children
- Living life beyond addiction
- > "Recovery is awesome, it takes a lot of work, but it's possible"
- > Support
- Hearing other's success stories
- The wins
- > It helps them cope with ongoing issues in their personal lives
