MAGISTRATE'S COMPLAINT

The Attorney General of Guam hereby accuses OCTOPUS PWIPWI aka Rambo Rambo aka Yamoan Rasta aka Rambo Milk aka Octopus Pew Pew of certain crimes committed as follows:

FIRST CHARGE

On or about the 20th day of July, 2019, in Guam, OCTOPUS PWIPWI aka Rambo Rambo aka Yamoan Rasta aka Rambo Milk aka Octopus Pew Pew, did commit the offense of *Indecent Exposure* (As a Misdemeanor), in that he exposed his genitals under circumstances in which his

conduct was likely to be observed by any person who would be offended or alarmed, in violation of 9 GCA § 28.65 and Public Law 32-126, as amended.

SECOND CHARGE

On or about the 20th day of July, 2019, in Guam, OCTOPUS PWIPWI aka Rambo Rambo aka Yamoan Rasta aka Rambo Milk aka Octopus Pew Pew, did commit the offense of Disorderly Conduct (As a Petty Misdemeanor), when he recklessly created a risk of public inconvenience, annoyance or alarm by making unreasonable noise, an offensively course utterance, gesture or display or addressing abusive language to Officer Medina, a person then present and the defendant intended to cause substantial harm or serious inconvenience or he persisted in the conduct after a reasonable warning and request to desist, in violation of 9 GCA §§ 61.15(a)(2), (b) and (c), as amended.

THIRD CHARGE

On or about the 20th day of July, 2019, in Guam, OCTOPUS PWIPWI aka Rambo Rambo aka Yamoan Rasta aka Rambo Milk aka Octopus Pew Pew, did commit the offense of *Public Drunkenness* (As s a Violation), when he appeared in a public place manifestly under the influence of alcohol to the degree he endangered himself or other persons and property or annoyed other persons in his vicinity, in violation of 9 GCA §§ 61.25(a) and (b), as amended.

DECLARATION

COMES NOW, Dannis L. Le, a duly appointed Assistant Attorney General, and aver, upon information and belief, that the foregoing is true. I have reviewed Guam Police Department ("GPD") Report No. 19-20871 which sets forth the following events occurred on Guam.

GPD Officer Medina (#288) was driving on Happy Landing Road on July 20, 2019 at approximately 3:56 PM when he saw Sgt. M.J. Lender struggling with a shirtless male. Officer Median stopped to assist. Sgt. Lender informed him the male, who stated his name was Octopus Pwipwi (DoB 11/18/84) ("Defendant"), had been urinating on the roadway and Officer Medina observed a corresponding wet spot on the roadway. Sgt. Lender stated that when he first encountered Defendant, he identified himself as a GPD Officer, but Defendant ignored him and continued urinating with his shorts down, buttocks and groin area, including penis, exposed.

While detained, **Defendant** then began screaming and yelling, ignoring Officer Medina's instructions to calm down. Officer Medina smelled a strong odor of intoxicating beverages emanating from **Defendant** who also displayed bloodshot, watery eyes and slurred speech. Officer Medina then arrested **Defendant**, who continued to yell and scream and use abusive language (e.g., "you fucking stupid!") to Officer Medina while being transported to the Precinct. The yelling and screaming continued through Defendant's confinement in a holding cell.

After his arrest by GPD and transfer to the Department of Corrections, Defendant's identity was confirmed as **Rambo Rambo** (DoB 11/25/85) who is also known as Milk Manutae, among other aliases.

Based on the foregoing, there is probable cause to charge with one (1) count of INDECENT EXPOSURE (as a Misdemeanor) in violation of 9 GCA §§ 28.65(a) and (b); 34.60(c); one count of DISORDERLY CONDUCT (as a Petty Misdemeanor) in violation of 9 GCA §§ 61.15(a)(2) and (c); and one count of PUBLIC DRUNKENNESS (as a Violation) in violation of 9 GCA 61.25(a) and (b).
