TO: The Supreme Court of Guam:

Guam Memorial Hospital Authority requests the court continue the oral argument hearing date currently scheduled for Wednesday, January 28, 2026, at 10:00AM until a later date after mid-February 2026. Counsel for GMHA has been on physician-authorized Family Medical Leave Act (FMLA) leave in the Philippines since December 12, 2025. The undersigned was initially anticipated returning to work mid-January. His clearance to work has now been extended to mid-February, and expects to remain off-island or otherwise unavailable through that time.

Additionally, during this period, the undersigned counsel's employment with Guam Memorial Hospital Authority has ended. Consistent with Guam Rule of Professional Conduct 1.16, subsection (c), the undersigned counsel seeks leave to withdraw as counsel of record from this matter. If leave to withdraw is granted, the matter will be transferred to another attorney for oral arguments and further proceedings.

Opposing counsel has been informed of the requested extension in this motion via telephone and has authorized the undersigned to advise the court that he does not oppose.

ORDER

This matter comes before the court on the Motion to Continue Oral Argument and Motion to Withdraw as Counsel, filed by Attorney Jordan Paulun on behalf of Petitioner-Appellant Guam Memorial Hospital Authority ("GMHA").
