A provision contained within §13103, as highlighted above, provides for the granting of such an extension and reads as follows: "...The Executive Director of the Election Commission shall grant extensions for the filing of financial reports herein required by officials; provided, however, that such extension shall not exceed one hundred eighty (180) days beyond April 22 of each calendar year".
