Last month was 165 violations, now 176, increase of 11. Last month 32 charged with another crime, now 41, increase of 9. In just 30 days, of the 176 persons (64 pretrial + 112 post-trial) in the attached report, 41 of the defendants were charged with ANOTHER crime and 8 out of the 41 defendants were charge for more than one crime (attempted murder, csc, agg. assault, poss. firearm, possession meth, fam. violence, theft, burglary, indecent exposure, resisting arrest, harassment, disorderly conduct, home invasion, crim. mischief, fel. restraint, felony on felony release, assault on police officer, car theft, child abuse, trespass) arguably creating **more crime victims**. The Court's prob. officers file daily violations against defendants. See www.oagguam.org for the “CR&R Radar” magistrate docs. detailing the attached report for each defendant. Defendants are innocent until proven guilty.

Something is broken needing a fast fix. Release conditions are not protecting us. The current numbers are untenable. Those released are victimizing more and more of us. Lock up those accused of meth addiction & career criminals to protect this Community. The numbers speak for themselves & trending upwards for months now.
