MAGISTRATE'S COMPLAINT

The Attorney General of Guam hereby accuses **RENATO CAPILI BOSI** of certain crimes committed as follows:

1 FIRST CHARGE

2 First Count

3 On or about the 1st day of May, 2016 through 31st day of May, 2016, *inclusive*, in Guam,
4 **RENATO CAPILI BOSI** did commit the offense of *Second Degree Criminal Sexual Conduct*,
5 when he intentionally engaged in sexual contact with another, to wit: by causing his hand to touch
6 the buttocks of A.D.G.(DOB:04/06/2002), a minor at least fourteen (14) but less than sixteen (16)
7 years of age, and **RENATO CAPILI BOSI**, was a member of the same household as of
8 A.D.G.(DOB:04/06/2002), or was related to A.D.G.(DOB:04/06/2002), by blood or affinity to the
9 fourth degree or was in a position of authority over A.D.G.(DOB:04/06/2002), and used this
10 authority to coerce A.D.G.(DOB:04/06/2002), to submit, in violation of 9 GCA §§ 25.20(a)(2) and
11 (b).

14 Second Count

15 On or about the 1st day of May, 2016 through 31st day of May, 2016, *inclusive*, in Guam,
16 **RENATO CAPILI BOSI** did commit the offense of *Second Degree Criminal Sexual Conduct*,
17 when he intentionally engaged in sexual contact with another, to wit: by causing his hand to touch
18 the primary genital area of A.D.G.(DOB:04/06/2002), a minor at least fourteen (14) but less than
19 sixteen (16) years of age, and **RENATO CAPILI BOSI**, was a member of the same household as
20 of A.D.G.(DOB:04/06/2002), or was related to A.D.G.(DOB:04/06/2002), by blood or affinity to
21 the fourth degree or was in a position of authority over A.D.G.(DOB:04/06/2002), and used this
22 authority to coerce A.D.G.(DOB:04/06/2002), to submit, in violation of 9 GCA §§ 25.20(a)(2) and
23 (b).

SECOND CHARGE

First Count

On or about the 1st day of May, 2016 through 31st day of May, 2016, *inclusive*, in Guam, **RENATO CAPILI BOSI** did commit the offense of *Fourth Degree Criminal Sexual Conduct*, when he did intentionally engage in sexual contact with another, to wit: by causing his hand to touch the buttocks of A.D.G.(DOB:04/06/2002), and used force and coercion to accomplish the sexual contact, in violation of 9 GCA §§ 25.30(a)(1) and (b).

Second Count


On or about the 1st day of May, 2016 through 31st day of May, 2016, *inclusive*, in Guam, **RENATO CAPILI BOSI** did commit the offense of *Fourth Degree Criminal Sexual Conduct*, when he did intentionally engage in sexual contact with another, to wit: by causing his hand to touch the primary genital area of A.D.G.(DOB:04/06/2002), and used force and coercion to accomplish the sexual contact, in violation of 9 GCA §§ 25.30(a)(1) and (b).

THIRD CHARGE

On or about the 1st day of May, 2016 through 31st day of May, 2016, *inclusive*, in Guam, **RENATO CAPILI BOSI** did commit the offense of *Child Abuse*, while having a child, namely A.D.G.(DOB:04/06/2002), in his care and custody, intentionally or knowingly subjected said child to cruel mistreatment, in violation of 9 GCA § 31.30(a)(2)(C), as amended.
