- 1 A Resolution urging the members of Congress to support
- 2 the Major Richard Star Act to allow medically
- 3 retired service members to receive full access to
- 4 their much-deserved retirement pay and benefits.
- 5 WHEREAS, Major Richard Star was an Iraq and
- 6 Afghanistan veteran who, after exposure to burn pits
- 7 during his service, received a diagnosis of lung
- 8 cancer; and
- 9 WHEREAS, due to his diagnosis, Major Richard
- 10 Star was forced to retire before completing 20 years
- ll of service and was therefore unable to collect his
- 12 retirement and disability benefits; and
- 13 WHEREAS, for every dollar of disability pay they
- 14 receive, veterans with less than 20 years of service
- 15 and a disability rating of less than 50 percent will
- 16 have their retirement pay reduced by a dollar; and
- 17 WHEREAS, an estimated 50,000 retired service members
- 18 are ineligible for concurrent benefits under the
- 19 current rules; and
- 20 WHEREAS, according to the Congressional Budget
- 21 Office, in 2022, the average offset was approximately
- 22 \$1,900 a month; and
- 23 WHEREAS, the Major Richard Star Act would remove
- 24 these restrictions and ensure that all service members
- 25 who have medically retired can receive full access
- 26 to retirement pay and department of veterans affairs
- 27 disability benefits; and
- 28 WHEREAS, after dying from his battle with lung

- 1 cancer in 2021, Major Richard Star's widow claimed
- 2 that his greatest goal was to get legislation passed
- 3 providing for the removal of these restrictions; and
- 4 WHEREAS, the United States owes these benefits to
- 5 its veterans regardless of the cost associated with
- 6 their allocation; NOW THEREFORE,
- 7 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES, That
- 8 the House of Representatives urges the Congress of the
- 9 United States to support the Major Richard Star Act
- 10 to allow medically retired service members to receive
- 11 full access to their much-deserved retirement and pay
- 12 benefits; and
- 13 BE IT FURTHER RESOLVED, That the House of
- 14 Representatives call upon our colleagues in the Senate
- 15 to urge the Congress of the United States to support
- 16 the Major Richard Star Act; and
- 17 BE IT FURTHER RESOLVED, That upon passage of
- 18 this resolution, the Chief Clerk of the House of
- 19 Representatives shall transmit copies of this
- 20 resolution to the President of the United States
- 21 Senate, the Speaker of the United States House
- 22 of Representatives, and each member of Iowa's
- 23 congressional delegation.
