NARRATIVE

On 13OCT2013 at approximately 0305hrs I observed a White Nissax X-Terra bearing Virginia Tag [REDACTED] drive through the stop sign located at the intersection of Morton Ave and Milledge Ave without stopping. I also observed that the passenger side brake light was cracked.

I got behind the vehicle and activated my emergency equipment to initiate a traffic stop. The vehicle turned right onto Springdale Ave from Milledge Ave where it came to a stop. When the vehicle made the right turn it turned very wide and was almost completely in the oncoming lane before the driver jerked the vehicle back into the right hand lane. The vehicle pulled alongside the curb, where it stopped.

When I approached the window I made contact with the driver, who I came to know as Hannah Spiegler. Immediately upon speaking to Ms. Spiegler, I detected the strong smell of an alcoholic beverage coming from her breath and person. I explained that I had stopped the vehicle for running the stop sign and for the wide turn in which the vehicle turned into the oncoming lane of traffic. I asked Ms. Spiegler where she was coming from and she said Waffle House and said that she had been at the Montgomery Gentry concert before that. When I asked if she had had anything to drink, Ms. Spiegler said "no" immediately followed by "I'm good." I found the expression "I'm good" to be an unusual expression for someone who had not consumed any alcohol. In my experience I have frequently heard the expression "I'm good" used by individuals who had been drinking but who believed that they were not overly impaired.

I took Ms. Spiegler's Virginia License bearing [REDACTED] and ran it through GCIC in my vehicle. I observed from Ms. Spiegler's license that she was 20 years old.

I then made contact again with Ms. Spiegler once again. I asked her to exit the vehicle and we moved to the rear of her vehicle. With her away from the other occupants of the vehicle I could still detect the strong odor of alcoholic beverage emanating from her breath and person. I told her that I could smell an alcoholic beverage and asked if she was being truthful when she said that she had not had anything to drink. She then told me that she had "pre-gamed a little before the game at 12." When I asked how many drinks she had at 12 she said "I probably had a drink." She then told me "I can do any test, I can walk the line and say my ABC's backwards." When I asked if she would consent to some field sobriety tests she said "I'd be happy to."

I then conducted the HGN evaluation. I asked if Ms. Spiegler had any medical conditions that would

affect her balance and she said "no". I then asked if she had contacts in and she said "no". I then conducted the HGN evaluation. I instructed Ms. Spiegler to keep her head stationary and follow the tip of the pen with her eyes and her eyes only. I confirmed that she could see the tip of my pen. I had to tell her three times to stop moving her head and follow the stimulus with her eyes only because she kept turning her head. During the evaluation, I observed a total of six clues. I observed a lack of smooth pursuit in the left and right eye, a distinct and sustained nystagmus at maximum deviation in the left and right eye and the onset of nystagmus prior to forty five degrees in the left and right eye.

I then began the walk and turn evaluation. In the evaluation I observed three clues. Ms. Spiegler did not maintain position in the instructional phase and attempted the test before I was finished with my instructions. During the walking phase she stepped off the line one time before the turn and did not touch heel to toe on almost all of her steps.

On the one-leg stand I observed two clues. Ms. Spiegler put her foot down one time she and was swaying.

I then asked if Ms. Spiegler would consent to blow in a hand held Alcosensor for the purposes of detecting the presence of alcohol on her breath. She agreed. The Alcosensor indicated a positive reading for the presence of alcohol.

I then asked if she was being truthful about how much she had to drink. She then said "I promise I just had a few drinks before the game." When I asked how many a couple was she said "I probably had a couple beers." She then told me that she went to "Sandbar" (a downtown bar) to watch the game.

Based on Ms. Spiegler's driving behavior, the strong smell of alcoholic beverage coming from her breath and the clues that I observed during the Standardized Field Sobriety evaluations, I placed Ms. Spiegler under arrest for DUI- Alcohol and Underage Possession/ Consumption of Alcohol.

I immediately read Ms. Spiegler the Georgia Implied Consent Notification for Suspects under the Age of 21 and specified "breath". She said "yes."

Ms. Spiegler's car was left secured on scene at her request.

I then transported Ms. Spiegler to the UGA Police Station for the State Administered Breath Test. The test was conducted by SPO Browning (Intoxilyzer Permit Number 39546). Ms. Spiegler returned two samples of .062 and .064 respectively both well in excess of the .02 statutory limit for suspects under the age of 21.

On October 13, 2013 I responded to the SAE House 247 Pulaski St. Athens-Clarke County, GA., on the report of an entering auto call.

I arrived and met with [REDACTED], who said that someone had entered his 2004 Chevy Silverado silver in color tag [REDACTED] North Carolina, and stolen his Apple Mac Book Pro from out of book bag that was in the rear seat. [REDACTED] said that he was last out at the vehicle around 11:45am 10/12/13. He said that when he went out to the vehicle around 2:30pm 10/13/13 he found that the computer was missing, but the bag was still there. He said that there was also papers and things pulled out of his center console, and glove compartment, but he had put those items back. [REDACTED] said that he thinks he left the driver's door unlocked; there were no signs of forced entry. He also said that there are cameras at the SAE House, and he had checked the video, but his vehicle was not in the camera view. I dusted the vehicle for prints, and recovered to prints from the driver's side. I have turned the latent print cards into evidence. There are no suspects at this time.

NARRATIVE

On 10/13/13 at approximately 0415 I responded to [REDACTED] in reference to a sexual battery. I arrived on scene and met with the victim, [REDACTED]

[REDACTED] said the incident occurred earlier at approximately 0230 - 0315. She was at The Globe at 199 N Lumpkin St at an after hours gathering with her friends. [REDACTED] is the [REDACTED] for The Globe and is a good friend to [REDACTED]. She knew that he is married and was having difficulties with his wife. While she was speaking with [REDACTED] he began making frequent physical contact with her. He then kissed her and felt her breasts and thigh with his hand. She had not consented to the contact.

Another friend and employee of the bar, [REDACTED] saw the interaction. He blamed [REDACTED] for the contact and physically threw her out of the bar. She was upset because he did not give her the opportunity to talk to [REDACTED] about what took place between them.

[REDACTED] is [REDACTED] who was there. [REDACTED] believed he witnesses [REDACTED] perform the unwanted sexual contact.

After [REDACTED] was kicked out of the bar she had contact with downtown officers. However, she told me she did not inform them of the sexual contact. Once she returned home she decided she needed to report the incident.

[REDACTED] appeared very upset about the incident. However, she was uncertain at this time as to whether she wished to press criminal charges. I gave her this case number and advised her of the process for applying for a warrant hearing.

Upon arrival, I made contact with the victim [REDACTED]. [REDACTED] stated that at 1727 hours, while walking west on Baxter St at Newton St, he was approached by 2 young black males. [REDACTED] stated that one of them asked to use [REDACTED]'s phone to call his mother. [REDACTED] stated that he agreed to let the individual use his phone and that the individual ran off with it without his permission.

The phone was described as a Black iPhone 5 16GB (\$500.00), with a white iCheer phone case (\$40.00) on it. The total amount stolen for this incident is \$540.00 dollars.

Due to a lack of information at the time of this report, no GCIC entry could be made. [REDACTED] was given a case reference card. Flex cam footage is available for this incident. MVR is not available because it was not activated.
