NARRATIVE

On 08-12-12 at about 2:10 AM I was dispatched to the call box at 137 Dr MLK Pkwy. When I arrived I met with a female who was identified as Rachel Blacklock. She said that her friends and boyfriend had left her downtown. She said she was not from Athens and needed help finding Bridgewater where her friend lived. Rachel was 18 years old and I could smell and extremely strong odor of an alcoholic beverage coming from her breath. I asked her if she had been drinking and she said she had. I placed her in handcuffs. She then told me that she had not had anything to drink before going downtown and that it was "downtown's fault" because she was let into the bars underage and not asked for her ID when getting drinks. I transported her to CCSO Jail where i issued her a citation for Underage Consumption of Alcohol.
