NARRATIVE

On 012914 at 0132 hours while traveling south on Lumpkin Street I observed what appeared to be an accident that had just occurred at the intersection of Lumpkin Street and Baxter Street. There was a vehicle parked in the roadway at the intersection in the southbound lane and two pedestrians lying in the roadway that were struck by the vehicle. ACCPD arrived on scene at approximately 0135 hours and the scene was turned over to them.

My Flex Camera was used to record SPO. Cusachs administer the Field Sobriety Exercise on the driver of the vehicle. A copy was burned and released to SPO. Cusachs.

As Lt. Gregory, Sgt. Seawright, and I were traveling south on Lumpkin Street and approached its intersection with Baxter Street, there was a vehicle without its headlights on stopped at the intersection. As we stopped behind the vehicle, we could tell there were people lying in the roadway in front of the vehicle. After we got to the front of the vehicle, we were able to tell there were two people lying in the road that had been struck by the vehicle. Sgt. Seawright approached the individual to the left, a female, and I approached the individual to the right, a male. I knelt down beside the male and asked him to remain still. Initially, he only complained of pain in his left calf but was visibly bleeding from his head. The male was unsure of what had happened but was able to speak coherently to me. He inquired about his girlfriend, told me her name, and asked me to tell her he was okay. As I was assisting the male, I noticed a brown wallet lying beside him. I held the wallet up so he could see it and asked if it was his. He asked me to open it up and look inside to confirm if it was or not. As soon as I opened it, there was a UGA Student ID with the name [REDACTED] on it. He confirmed that was him and told me I could continue to look in the wallet for his driver's license. I located a Georgia Driver's License issued to [REDACTED] and logged the OLN with Dispatch. I then placed the license back in the wallet, secured the wallet in [REDACTED] right coat pocket (Owen was wearing the coat), and notified [REDACTED] and EMS personnel where the wallet was. EMS personnel told me they were transporting him to Athens Regional. I relayed his name, OLN, and hospital information to SPO Meagher, an ACCPD officer who had arrived on scene and began investigating the accident.

After the accident, I was assisting a United Taxi at the same intersection. The taxi was traveling north on Lumpkin, and the driver stated he was trying to go downtown. I helped get the taxi turned around in the intersection because fire trucks, ambulances, and police vehicles were blocking his direction of travel. As the taxi turned and started south on Lumpkin, the front seat passenger, later identified as [REDACTED], leaned out the window and stated the vehicle involved in the accident did not have its headlights on when the accident occurred. I asked the taxi to stop, confirmed what the passenger said, and recorded her contact and identifying information. I relayed this information to SPO Cusachs, another ACCPD officer who was at the scene investigating the accident, and SPO Meagher.

My flex cam was used for this incident.
