NARRATIVE

On the listed dates and times I observed a motorcycle leaving the area of downtown at a high rate of speed. I turned around on the motorcycle at Oconee St. and Foundry St. as I started back east bound I saw GSP 169 turnaround in front of me. At this time the motorcycle was at Oconee St. and Williams St. when I got to that intersection I could see a single taillight going up Oconee St. where it splits into Oak St. GSP went down Georgia Dr. and I continued up Oconee St. I turned down China St. where I observed a white male in a with a silver helmet and a black jacket getting off of a motorcycle.

I called out my location and asked Central to get in contact with GSP to see if they got a description of the rider or the motorcycle.

I made contact with the driver of the motorcycle who identified himself as told me he was coming from The Grill downtown. I could smell the strong odor of an alcoholic beverage coming from his person. I could also see that his eyes were bloodshot and watery and that he was swaying while I was speaking to him. I asked how much he had to drink and he told me two pints of beer over a three hour period which meant he was sober. He told me that he was riding the blue Kawasaki tonight because his wasn't running. When GSP 169 arrived he told me that he recognized. He took over the DUI investigation.
