Notes/Narratives**NARRATIVE**

On 110913 at 2347 hours dispatch received a call from housing staff at Busbee Hall in reference to a report of an individual concerned about possible drug behavior occurring in her dorm room. At 2349 I was dispatched to Rooker Hall to meet with the reporting party.

When I arrived on scene I met with the reporting party. He stated that he was made aware of the possibility of drugs and knives on the premises of Busbee Hall at approximately 1930 hours on 110913. He stated that one of the occupants of the room came to him and explained that she had encountered the drugs and knives during interaction with guests staying on behalf of her roommate and did not feel comfortable staying in her room until the guests were gone. A second member of housing staff relayed information about an interaction he had with the above mentioned individuals at 0300 hours on 110913 while at Busbee Hall.

An attempt to contact the originating complainant was made and a message was left on her voicemail.

SPO Vogt and I went to the suspected room and did not observe anyone on the premises and were given no indication that there was crime afoot.

I then advised the reporting party that follow-up with the complainant and contact at the room would be made again at a later time.

Notes/Narratives**NARRATIVE**

On 111113 at 1035 hours I responded to the University of Georgia Police Department in reference to a phone report. I spoke with the victim, [REDACTED], over a recorded line in Dispatch. [REDACTED] advised that between 1630 hours on 110813 and 1100 hours on 111013 a black laptop bag (value \$30) containing several items went missing from the trunk of his vehicle, a 2013 Chevrolet Camaro. The items included a silver Apple Macbook (value \$1000), a gray HP laptop (value \$500), a black wireless mouse unit (value \$25), and a Bank of America bank statement (value \$1). [REDACTED] last saw the bag and its contents when he was packing for his trip to campus from Augusta at 1630 hours on 110813. He noticed them missing when he was preparing to return to Augusta. He parked his vehicle in several locations on campus to include the ECV surface parking lot (E06), the North Deck, and the Ramsey Pay parking lot. The items were kept in his trunk, which he kept locked while on campus. Due to [REDACTED] not being in town, I could not obtain any evidence from the vehicle. The total value stolen was \$1556. No GCIC entries were made due to lack of serial numbers. I provided [REDACTED] the case number over the phone. My flex camera was not in use during this incident. The MVR in vehicle 94863 was not in use during this incident.

Notes/Narratives**NARRATIVE**

On 11/11/2013 I responded to the Varsity in reference to an armed robbery that was reported at this location. When I arrived on scene I met with [REDACTED] (victim) who told me that he was robbed in the parking lot of the varsity this date.

According to [REDACTED], he has arranged to meet with a male named [REDACTED] later identified as [REDACTED] to meet and purchase two laptops from [REDACTED]. [REDACTED] said that he got a call at around 1900 from [REDACTED] who said that he would meet [REDACTED] in the parking lot of the Varsity for the transaction.

[REDACTED] said that he arrived at the Varsity and walked around to the rear entrance of the business (which faces Reese St.) and saw [REDACTED] walking on the sidewalk (which faces Milledge Ave) toward the rear of the business. According to [REDACTED], he and [REDACTED] walked further to the rear of the business, near the drive through. [REDACTED] said that [REDACTED] asked him, "you got the money"? According to [REDACTED] he had been speaking with [REDACTED] off and on all day on the phone and stated that he knows [REDACTED].

[REDACTED] said that he told [REDACTED] that he had the money and pulled cash out of his pocket. It was at this point, according to [REDACTED] that [REDACTED] pulled out a black handgun and held it close to his side, pointing it at [REDACTED]. [REDACTED] stated that [REDACTED] said, "you know what this is", and demanded the money from [REDACTED]. [REDACTED] said that he handed the money over to [REDACTED], and that [REDACTED] got into a green Honda Accord.

[REDACTED] said that there was a white female in the driver's seat and a white male in the rear passenger seat. [REDACTED] sat in the front passenger seat. According to [REDACTED], the car left the rear parking lot of the Varsity (it had been parked near the drive through), and headed west on West Broad St.

SPO B. Norman was in the area and had stopped by the scene. When he heard that the suspect was possibly a [REDACTED] he checked his computer and realized that he had made a traffic stop earlier this date on a 96 Honda Accord with tag number PGF7379. According to SPO Norman, [REDACTED] was the driver of that vehicle.

[REDACTED] said that after [REDACTED] and the others left the parking lot, he got into his car with his girl and that they drove around for several minutes looking for the suspect vehicle. According to [REDACTED] he returned to the Varsity after about 15 minutes and called the police.

CID responded to the scene (Det. C. Ivey) and interviewed [REDACTED] and the female that was with him.
