Upon contact with the driver Stephaine Hoy I could smell a strong odor of an Alcoholic beverage emitting from the passenger compartment. I noticed she had slurred speech and red watery eyes.

Due to what I observed I asked Hoy if she would do SFSTs. She agreed. I observed 6 clues in HGN, 3 clues on WAT and 1 clue on OLS.

Hoy was placed under arrest for DUI. She was read implied consent for 21 and over breath. She agreed. She blew a .180 and .182.

Hoy was transported and turned over to Clarke County Jail.
