NARRATIVE

On 02/13/13 at 0215 hours, I was in front of the Lay-Z-Shopper convenience store and was informed by the store manager [REDACTED] that a white male was inside the establishment attempting to shoplift. [REDACTED] pointed out the suspected male to me inside the store. The male that I observed had a youthful appearance and was highly intoxicated (loud boisterous behavior, slurred speech, and poor delayed motor skills). I observed that the male had paid for items that he had opened, but never paid for items that he had concealed in his pockets (candy bars).

I had contact with the male and he was identified as Alexander Af Ursin. Immediately upon having contact with Af Ursin, I noticed that he had a strong odor of an alcoholic beverage coming from his breath. Af URsin's driver's license identified him as being underage, at which time I placed him under arrest for Underage Consumption. Ahmed refused to prosecute Af Ursin for shoplifting since he was intoxicated and not of sound mind.

Af Ursin was transported to the Clarke County Jail.
